FEDERAL REGULATIONS HAVE CHANGED: All CDL holders must prove U.S. Citizenship or legal presence and residency. To determine if you must apply in person please contact our customer call center at 717-412-5300.

In accordance with the Motor Carrier Safety Improvement Act of 1999, you must provide the names and driver's license numbers (if known) of all States where you have previously been licensed to drive any type of motor vehicle during the previous 10 years. If there is not enough room, attach additional information on white paper. Include your current Pennsylvania driver's license number and your full name. PennDOT will review the driver histories from States listed and may assess sanctions, if required.

• Veterans Designation: You have the opportunity to add the veterans designation to your driver's license, which clearly indicates you are a veteran of the United States Armed Forces. To qualify, you must have served in the United States Armed Forces, including a reserve component or the National Guard, and have been discharged or released from such service under conditions other than dishonorable. If you are requesting to add the veterans designation to your license, make sure you check the box at the top in Section C.

EXTEND A PERMIT: Permits can be extended only for one year. If you have already extended your permit once or the permit is more than a year old, you will be required to retake all applicable knowledge tests. Additionally when extending a permit all previously passed skills test are no longer considered valid. If you wish to only replace a Lost/ Damaged permit please use DL-80CD form and request duplicate. **NOTE:** If extending or upgrading your permit, you must surrender your existing permit.

- RENEWAL FEE: PLEASE NOTE: If your license expires within 6 months, you must renew your license prior to applying for a CDL learner's permit.
- INCREASE FEE: A CDL costs \$18.00 more per year than a non-commercial license. Pay the appropriate increase fee if you are currently licensed as a non-commercial driver. If you already have a PA CDL, you do not have to pay an increase fee.
 - To calculate the number of months to use for your increase fee, look at your current license. Count the current month up to and including the month your license expires. EXAMPLE: If the current month is May, and your license expires in July, you would use 3 months for your required increase fee. If your license expires in:

0-6 Months	Don't pay an increase	e fee. Your annual fee is co	ontained in the renewal fee.
7-12 Months	\$18.00 is due	25-36 Months	\$54.00 is due
13-24 Months	\$36.00 is due	37-48 Months	\$72.00 is due

- + HAZMAT FEE: The \$18.00 fee is required for the original issuance or renewal of a CDL with an "H" or "X" endorsement. Include this fee if:
 - · You have applied for a Hazardous Materials permit, regardless of your existing class of license, or
 - You are already a CDL driver with an "H" or "X" endorsement on your license and you are renewing with this form. (You must have passed your HAZMAT recertification prior to renewing your CDL or you will be decertified.)
 - Federal regulations issued in support of the USA PATRIOT Act affect drivers wishing to obtain or retain a hazardous materials endorsement. At the time
 you pass your Hazardous Materials Knowledge Test, you will additionally need to provide proof of US citizenship or appropriate immigration status,
 complete form DL-288, pay additional fees, submit fingerprints and undergo successful completion of a Federal criminal history background check.

- PHOTO FEE:
 All applications require a photo fee except if you have previously been issued a CDL permit for the exact same categories you are applying for on this application. EXAMPLE: You previously received a CDL permit for Class B and a P Endorsement, but did not successfully pass testing. On this application, you again apply only for a Class B and a P Endorsement. In this example, no photo fee would be due. When you pass your permit test(s), you will receive a new license reflecting your new status.

ORGAN DONATION AWARENESS TRUST FUND (ODTF): You have the opportunity to contribute \$3.00 to the Fund. The additional \$3.00 contribution must be added to your payment. You must also check the block provided to ensure proper handling of your contribution. The ODTF provides for the development and implementation of donor awareness programs and funds shall be appropriated subject to the approval of the Governor.

VETERANS' TRUST FUND (VTF): You have the opportunity to make a tax deductible contribution to the VTF. Your contribution will help support programs and projects for Pennsylvania veterans and their families. Since this additional \$3.00 is not part of the fee, please add the donated amount to your payment. Also, please check the proper block on the form to ensure your contribution is handled properly.

Please do not use this form to make any change or correction to your information. If you currently hold a PA non-commercial license, attach form DL-80 to make your corrections. If you currently hold a PA CDL, use form DL-80CD and include the appropriate fees. Form DL-80CD will require notarization. These forms are available on our website at www.dmv.pa.gov.

COMMERCIAL LICENSE INFORMATION

- A permit to operate any combination of vehicles with a gross combination weight rating of 26,001 pounds or more, provided the gross vehicle weight rating of the vehicle(s) being towed is in excess of 10,000 pounds. (HOLDERS OF CLASS A LICENSE MAY, WITH APPROPRIATE ENDORSEMENTS, OPERATE VEHICLES WITHIN COMMERCIAL CLASSES B & C.)
- CLASS B A permit to operate any single vehicle with a gross vehicle weight rating of 26,001 pounds or more, or any such vehicle towing a vehicle not in excess of 10,000 pounds. (HOLDERS OF A CLASS B LICENSE MAY, WITH APPROPRIATE ENDORSEMENTS, OPERATE ALL VEHICLES WITHIN COMMERCIAL CLASS C.)
- CLASS C A permit to operate any single or combination vehicle that does not meet the definition of Class A or Class B and requires the H or P endorsement. Holding this class license does not authorize operation of vehicles requiring motorcycle classification.

ENDORSEMENTS - The following authorizations are required when operating vehicles of the type listed.

- S SCHOOL BUS (When adding an "S" endorsement, you must attach a School Bus Physical Exam Form DL-704)
- *H TRANSPORTING HAZARDOUS MATERIALS *X HAZARDOUS MATERIALS AND TANKER VEHICLE (H & N)
- **P** PASSENGER (*Required if applying for "S" endorsement*) **T** DOUBLE AND TRIPLE TRAILERS

*In accordance with Federal and State Hazardous Materials Regulations, operators of vehicles which require the "H" or "X" endorsement must be 21 years of age or older.

Upon issuance of a commercial learner's permit, you will be subject to commercial driver penalties for any violations committed.

RESTRICTIONS - The following restrictions prohibit you from operating certain type vehicles:

C/N - May not drive a Class A or B bus (MUST be removed to operate Class B bus).	B/M - May not drive a Class A bus	L - NOT EQUIPPED WITH AIR BRAKES (MUST be removed to operate vehicle with air brakes).	
E - Operate Manual Transmission	Z - Prohibits driving a commercial motor vehicle with full Air Brakes.	O - Operate a Tractor Trailer	

NOTE: Restrictions will be placed on your license based on the vehicle you were tested in.

PROVISIONS OF SECTION 3709 OF THE VEHICLE CODE

Section 3709 provides for a fine of up to \$300 for dropping, throwing or depositing, upon any highway, or upon any other public or private property without the consent of the owner thereof or into or on the waters of this Commonwealth, from a vehicle, any waste paper, sweepings, ashes, household waste, glass, metal, refuse or rubbish or any dangerous or detrimental substance, or permitting any of the preceding without immediately removing such items or causing their removal.

For any violation of Section 3709, I may be subject to a fine of up to \$300 upon conviction, including any violation resulting from the conduct of any other persons present within any vehicle of which I am the driver.
