Masimo SafetyNet is a secure cloud-based software platform that allows providers to customize interactive digital CarePrograms™ for their patients.

Masimo SafetyNet can be utilized by providers to:

- At-a-glance view of all patients under their care on a comprehensive dashboard.
- View physiological data from patient-connected devices, presented with charts and trends.
- Enroll patients in clinically prescribed CarePrograms which deliver education, reminders, and alerts.
- Manage user access to the data being aggregated and displayed.

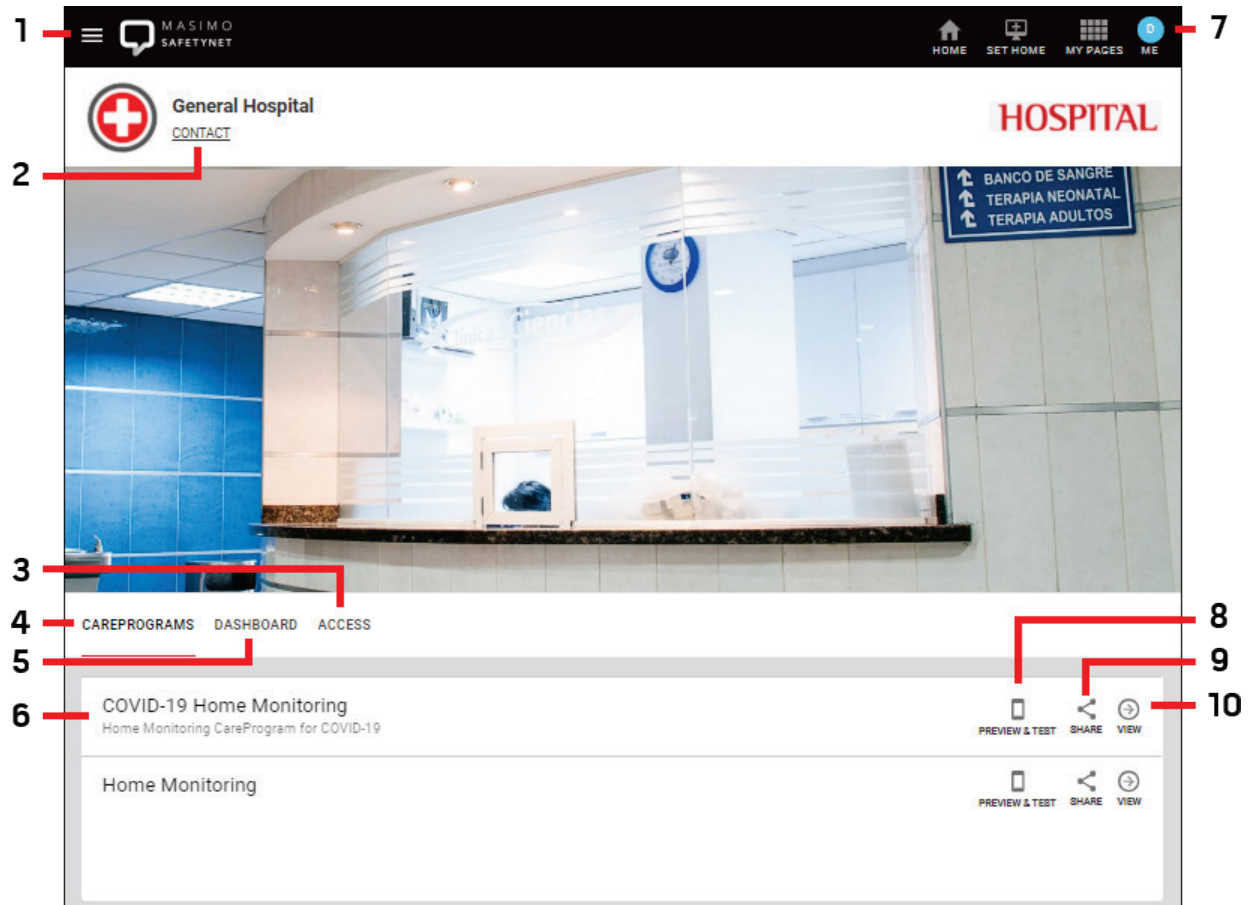

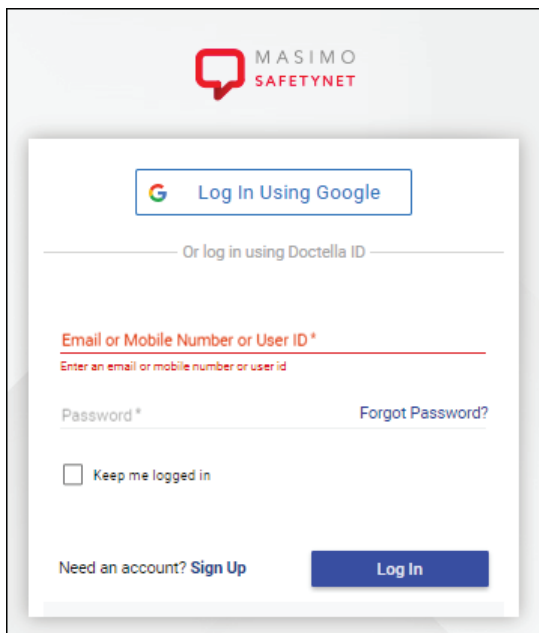
Accessing and Logging Into Masimo SafetyNet

To access and log into the Masimo SafetyNet Clinician Portal:

1. Using a compatible web browser, go to www.masimosafetynet.com. See **Supported Browsers** on page 19.
2. Scroll down and select **Log In To Masimo SafetyNet**. The Log In screen displays.

Log Into an Existing Account

On the log In screen, enter the login information in the required fields and click the **Log In** button. If an account has not yet been created, select **Sign Up**.

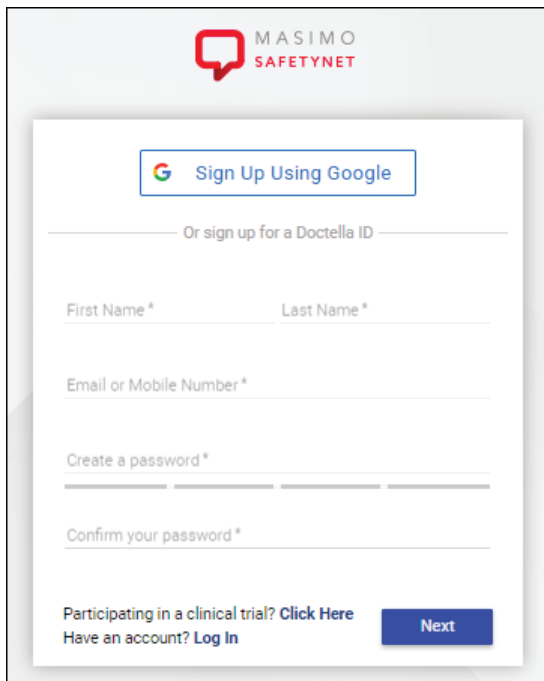

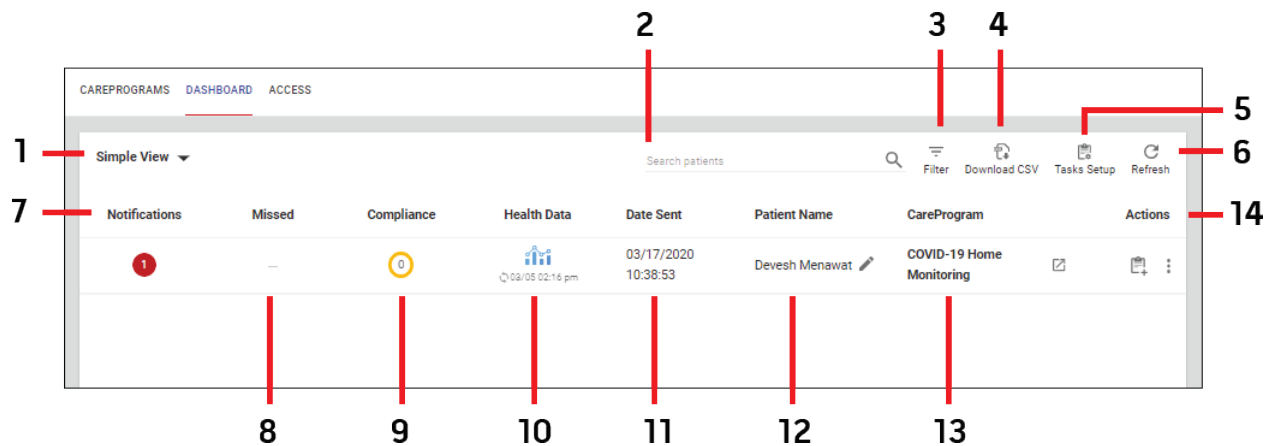

More Details Window

When certain options are selected from the *Dashboard*, the *More Details Window* displays patient information. Additional patient information can be populated from the *More Details Window* (e.g. Medical record Number, DOB, Outcomes). Selecting the clock icon next to *Patient Activity* and *Provider Activity* opens a new window displaying the list of activities, the activity dates and who performed the activity. Select the "X" to close the window.

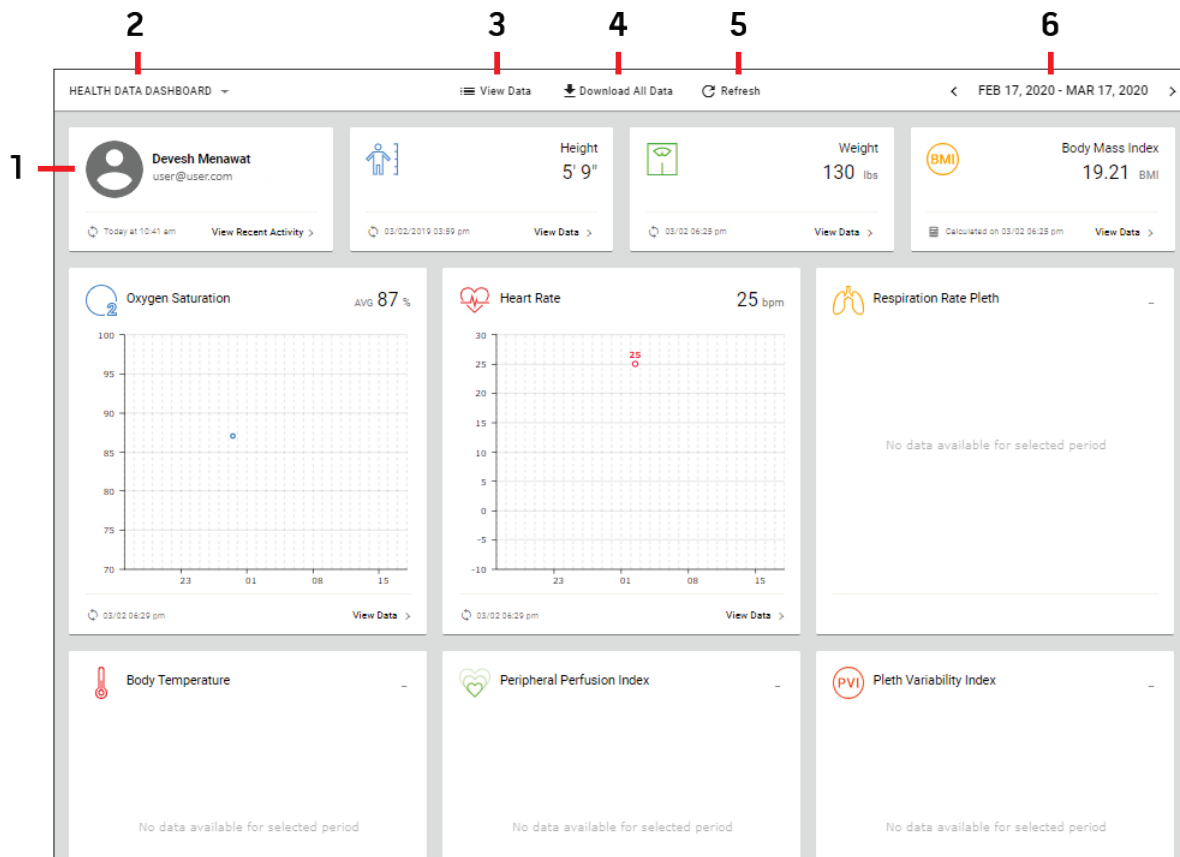
Task List

Health Data Dashboard

The *Health Data Dashboard* displays health information for the patient. From the *Health Data Dashboard* screen, additional data can be accessed and viewed by clicking on the available links on the screen.

Share a CareProgram

Sharing a care program invites a user to download the Masimo SafetyNet App, create an account, log into the app, and share their personal health data with the CareProgram clinician through the Masimo SafetyNet Clinician Portal.

To share a CareProgram, perform the following:

1. From the *Clinician Portal*, select *Share*. See **Masimo SafetyNet Clinician Portal** on page 7.

- In the CareProgram window, enter a recipients first and last name (1), email address or mobile telephone number (2), enter a message to the recipient (3) (leave *Track Progress in Dashboard* (4) checked) and select **Send** (5).

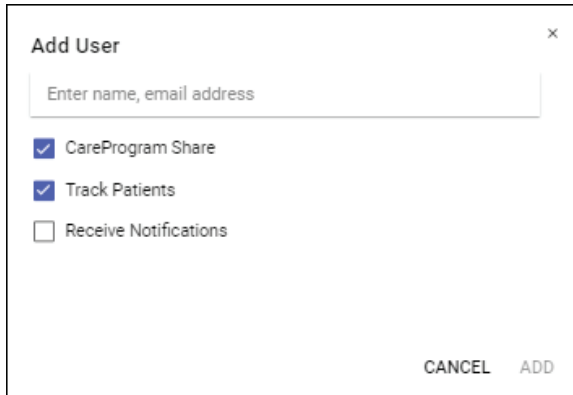

Add, Edit or Remove User

Add User

1. To add a new user to Masimo SafetyNet, while viewing the Access screen, select the *Add User* icon.
2. In the *Add User* window, enter the new users name and email addresses (separated by a comma) and check the boxes for the desired user options.

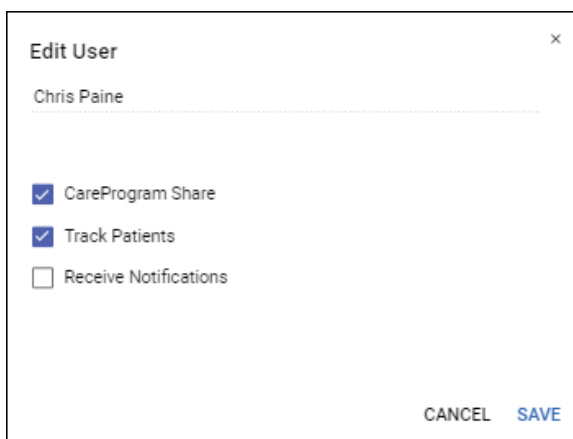


3. Select **Add** to add the new user, or **Cancel** to cancel adding.

Edit User

Note: The users name cannot be edited. If a correction to the user name must be made, the user should be removed, and added again with the correct name. See **Remove User** and **Add User** information.

1. To edit an existing user's information, while viewing the Access screen, select the *User Menu* icon at the right end of the user row.
2. Select *Edit* from the available options.



3. In the *Edit User* window, change the desired user options.
4. Select **Save** to save the user edits, or **Cancel** to cancel editing.

Remove User

Note: A user cannot be removed when currently logged into Masimo SafetyNet. If a user must be removed, the user must first be logged out.

1. To remove a user from Masimo SafetyNet, while viewing the *Access* screen, select the *User Menu* icon at the right end of the user row.
2. Select *Remove* from the available options.
3. When the *Remove Member* window displays, select **Yes, Remove** to remove the member (user), or **Cancel** to keep the member.
4. The user will be removed from the list and Masimo SafetyNet.

User Log

The *User Log* displays actions performed by specific users along with the date and time. Select **Close** or "X" to close the window.

Troubleshooting the Masimo SafetyNet

The following section lists possible symptoms, the potential cause, and next steps.

See Accessing and Logging Into Masimo SafetyNet on page 9. • Ensure the Masimo SafetyNet equipment is connected to a network and communicating. • Contact the Masimo SafetyNet administrator. • If the issue continues, contact the network administrator.
<i>Cannot find the desired data on the Dashboard</i>	• Wrong view has been selected. • Data displayed is not current. • Correct patient is not displayed. • Correct date span is not selected.	• Ensure the desired view is selected and configured correctly. • Refresh the dashboard using refresh button. • Search for the patient using the search function. • Use the filter function to select a different date range. • See Masimo SafetyNet Dashboard on page 11.
