In this Extended Warranty: a) 'ACL' means Australian Consumer Law pursuant to schedule 2 of the Competition and Consumer Act 2010. b) 'Appliance' means the Electrolux appliance covered by an Extended Warranty. c) 'Electrolux' means Electrolux Home Products Pty Ltd of 163 O'Riordan Street, Mascot NSW 2020, ABN 51 004 762 341. d) 'Extended Warranty' means the rights referred to in this document and includes an extension of the rights and privileges offered as part of the Appliance's Warranty. e) 'Extended Warranty Period' means the period which is 3 years over and above Electrolux's Warranty for an Appliance. 1) 'Purchaser' refers to you, the person who purchases the additional coverage offered as part of the Extended Warranty and whose name is stated on the Extended Warranty Certificate. g) 'Warranty' means the warranty included with the Appliance to which this Extended Warranty applies. 2. Electrolux Appliances come with a guarantee that cannot be excluded under the ACL. A Purchaser is entitled to a replacement or refund for a major failure and for compensation for any other reasonably foreseeable loss or damage. A Purchaser is also entitled to have the Appliance repaired or replaced if the Appliance fails to be of acceptable quality and the failure does not amount to a major failure. The benefits to a Purchaser given by Electrolux's Warranty are in addition to the Purchaser's other rights and remedies under a law in relation to the Appliances or services to which Electrolux's Warranty relates. 3. The purchase of an Extended Warranty confers on a Purchaser's rights which are in addition to those rights conferred on a Purchaser under the Electrolux Warranty. 4. The benefits offered to a Purchaser as part of an Extended Warranty are in addition to the rights conferred on a Purchaser under the ACL. An Extended Warranty does not restrict a Purchaser's rights or remedies under the ACL. In purchasing an Extended Warranty, the Purchaser is buying benefits in addition to the rights available under the ACL. 5. An Extended Warranty provides the Purchaser with a clear and prescriptive process to follow which provides certainty, peace-of-mind and convenience. In the event the Appliance covered by an Extended Warranty cannot be repaired and is replaced, the balance of this Extended Warranty will be transferred to the replacement Appliance. As an example, if an Extended Warranty is valid for a remaining 1 year period and the covered appliance is replaced, you receive a new Electrolux Warranty plus the remaining 1 year of the Extended Warranty. 14. Any personal information included as part of this Extended Warranty will be handled and stored by Electrolux in accordance with the Privacy Act 1988 (Cth) and the National Privacy Principals. The Purchaser accepts their personal information will be used by Electrolux and its agents and/or representatives before and after 12 March 2014 in order to provide services in line with these terms and conditions. Electrolux may also pass on personal information to third parties at the expiration of this Extended Warranty in order to offer an extension of these terms and conditions. Personal information may also be used as part of research to improve products and services, auditing to rectify errors and/or addressing any complaints. You are entitled to have access to the personal information about you and held by Electrolux. 15. By purchasing an Extended Warranty plan a Purchaser accepts these terms and conditions.
