



GETTING STARTED



Set up your PlayStation[®]2 computer entertainment system according to the instructions in its Instruction Manual. Make sure the MAIN POWER switch (located on the back of the console) is turned ON. Press the **RESET** button. When the power indicator lights up, press the **OPEN** button and the disc tray will open. Place the **GRAND THEFT AUTO: SAN ANDREAS** disc on the disc tray with the label side facing up. Press the **OPEN** button again and the disc tray will close. 
