The contractual agency which is registered with Govt./ Semo-Govt. organization will not be allowed to participate in bids floated by the MCGM unless and until it is registered with MCGM in required class. The contractor shall have their office in Mumbai. **JOINT VENTURES or CONSORTIUM WILL NOT BE ALLOWED FOR THIS TENDER.**

All interested vendors /contractors whether already registered or not registered with MCGM are mandated to get registered with MCGM for e-tendering process & obtain login credentials to participate in the online bidding process.
