In unusual circumstances, the \$300 maximum allowance may not cover the full cost of fitting your new 27" or 30" Amana Brand built-in wall oven into your existing cabinet; you are solely responsible for all costs that exceed the \$300 maximum cabinet modification allowance. Amana makes no other guarantees as to the proper fit of your new Amana Brand 27" or 30" built-in wall oven other than as set forth herein.

② WITHIN 90 DAYS of the purchase or delivery date (whichever is later), mail the following documents to the address provided by the *Fit System Limited Guarantee Service Representative*:

- i) This completed and signed claim form;
- ii) a legible copy of your sales receipt dated between **1/1/18-12/31/19** and proof of the delivery date, if utilizing the delivery date to calculate the 30/90-day claim periods;
- iii) a photograph of the existing oven model that is being replaced; and
- iv) a dated invoice or receipt from a professional installer or contractor stating the cost to modify your existing cabinet.

Retain a copy of all documents for your records. Allow 8 weeks from the date your claim form is mailed for delivery of claim payment.
