PENTROL™ is designed to combine the penetrating activity of a phytobland oil with the wetting and dispersing characteristics of a surfactant. PENTROL increases the efficiency of certain herbicides in post-emergence applications.

Read the label of the herbicide carefully and follow any restrictions on combining that herbicide with an adjuvant. Keep container tightly closed and DO NOT allow water to be introduced to the contents of this container.

NOT FOR AQUATIC USE IN CALIFORNIA OR WASHINGTON.

ENVIRONMENTAL HAZARDS

Do not apply directly to water or to areas where surface water is present, or to intertidal areas below the mean high-water mark. Do not contaminate water when cleaning equipment or disposing of equipment wash waters.

DIRECTIONS FOR USE

MIXING INSTRUCTIONS:

Fill spray tank one-half full of water.

Add the required amount of herbicide while agitating. Add remainder of the water.

Add the recommended amount of PENTROL last and continue agitation until completion of spraying.

GENERAL: Use 1-8 pints of PENTROL per acre. Always follow the adjuvant use recommendations as shown on the herbicide label.

DO NOT ADD THIS PRODUCT AT A RATE WHICH EXCEEDS 2.5% OF THE FINISHED SPRAY VOLUME.

BACKPACK AND HANDHELD SPRAYERS: Use 1-2 tablespoons (1/2 -1 fluid ounce) per gallon of spray. Follow the adjuvant use rates and recommendations that are shown on the pesticide label.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.
