By participating in **The Honda Civic Tour Sweepstakes** (the “Sweepstakes”), each Entrant (“Entrant”) unconditionally accepts and agrees to comply with, and abide by these Official Rules (the “Official Rules”) and the decisions of American Honda Motor Co., Inc. (the “Sponsor”) and US Sweepstakes & Fulfillment Co. (the “Sweepstakes Administrator”), which shall be final and binding in all respects.

Each Second Prize winner will receive one (1) "Concert In A Box" prize package consisting of concert related merchandise. Merchandise items included in the "Concerts in A Box" is at the sole discretion of Live Nation and Artist. **The ARV of each Second Prize is \$300.** The odds of winning a Second Prize are dependent upon the number of eligible Entries received during Entry Period #2. There is a limit of one (1) Second Prize per person.

**Grand Prize:** There is one (1) Grand Prize available to be won. One (1) Grand Prize winner will receive one (1) 2022 Honda Civic Sedan Sport. **The ARV of the Grand Prize is \$24,045.** The 2022 Honda Civic Sedan Sport (the "Vehicle") will be delivered to an authorized Honda dealership (the "Authorized Honda Dealership") located near the Grand Prize winner's residence as determined by the Sponsor in its sole discretion. The Grand Prize winner will be responsible for pick-up of the Vehicle at the Authorized Honda Dealership.
