Terms and Conditions

1. Legal parties involved in YZ125 Cup

- a) Yamaha Motor Europe N.V. (hereinafter referred to as Yamaha Motor Europe);
- b) Yamaha Motor Europe N.V. national distributors (hereinafter referred to as National Distributors);
- Youthstream Group Lda. (hereinafter referred to as Youthstream);
- fédération Internationale de Motocyclisme (hereinafter referred to as FIM).

2. Involvement of legal parties

- a) Yamaha Motor Europe sets the structure and rules for the YZ125 Cup and is the entity in charge of the interaction between the stakeholders involved in this project;
- The National Distributors are in charge of the local communication and direct contact with the riders, providing them the BluCru welcome pack and sticker kit;
- Youthstream is the entity which manages the television, marketing and promotional rights for the YZ125 Cup, apart from organizing the Superfinale in Veltins Arena. Youthstream is the stakeholder which establishes direct contact with FIM regarding the Superfinale;
- d) FIM guarantees the licensing for the YZ125
 Cup Superfinale, which includes the insurance exclusive for the Superfinale event.

3. Structure of the Cup

- a) National Championships
 This Cup will be an integrant part of the national championships, in which the Yamaha riders will have their own ranking, which will be freezed by the 12th of September for the selection of riders joining the Superfinale;
- b) Superfinale in Veltins Arena
 The best riders of each national championship will race in a Superfinale which will happen on the 8th of October of 2016 at Veltins Arena, Germany and will be part of the main event "Riders and Manufacturers Cup";
- Master Class with David Phillipaerts
 The top 6 riders plus 2 wild cards chosen by a jury from the Superfinale at the Veltins Arena will then participate on a multiple day Master Class with David Philippaerts;
- d) EMX 2017 ride The best rider of the Master Class, chosen by David Philippaerts, will join Yamaha official EMX 2017 team as a rider.

4. Participation Requirements

- a) The participation in this Cup is restricted to the following national championships:
 - United Kingdom
 - Germany
 - France
 - Belgium
 - Italy
 - Portugal
 - Switzerland
 - Netherlands
 - Spain
 - Finland
 - Sweden
 - Greece
 - Austria
- The rider must be fully licensed in their national federation and racing with a Yamaha YZ125 for a championship of the countries mentioned on point a)
- In order to participate in this Cup, the rider must have been born between 2000 and 2004.
- d) It is mandatory for the riders participating in this Cup to use during both national championship season and Superfinale, the Sticker Kit provided by Yamaha Motor Europe.

5. Insurance

- a) The insurance for this Cup is a responsibility of each national federation and, regarding specifically the Superfinale, of FIM;
- b) The indemnity and liability clauses are set by the insurance included in the FIM and national federation licenses;
- c) Yamaha Motor Europe and the National Distributors are excluded from any responsibility in case of accident that causes any injury, permanent disability or death.

6. Attendance at the events

- a) The riders must be racing on their national championship and need to attend to a minimum of 2 races in this championship in order to be able to participate in the Superfinale;
- b) The riders who manage to reach the following step in this Cup, will have to attend to it, unless in case of major force (injury, severe health problem)

Terms and Conditions

7. Costs

- a) All the participation costs of this Cup will be on the rider/ team responsibility (logistic, bike, parts, mechanical, licensing on national championships);
- b) There is no subscription fee for this Cup, including the Superfinale, Master Class and EMX125 ride (excluding national championship licensing and participation fees defined by the national federation);
- c) Yamaha Motor Europe will provide a cost-free BluCru welcome pack (T-shirt, Cap, Sticker Badge) and a Sticker Kit for the riders Yamaha YZ125:
- d) In case the rider requires more Sticker Kits, these should be requested from Yamaha Motor Europe, through <yz125cup@yamaha-motor. nl> and these will be provided for a "reduced price" fee.

8. Joining Instructions

- a) To join this Cup, it is mandatory to fill in the complete registration form and send it to <yz125cup@yamaha-motor.nl>;
- The rider will then receive a confirmation email and the rider's registration is only confirmed and finalized after this;
- All the information provided by the rider must be correct and true, as this will be checked by Yamaha Motor Europe.

9. Cancellation of events

 a) Due to any unexpected major events/ risks, Yamaha Motor Europe reserves the right to cancel the event

10. Prize transfers

 a) All the riders who manage to reach the next stage in this Cup, are not authorized to transfer the prize/ place to third parties.

11. EMX125 2017 participation conditions

- a) The best rider chosen from the Master Class will be participating in EMX125 championship in 2017 for the Yamaha official team;
- b) The rider will be fully supported by Yamaha as an official rider under the conditions of a contract with Yamaha Motor Europe;
- c) The rider participating in the EMX125 will have to follow the rules and instructions of the team, including sponsorship agreements.

12. Applicable law

- a) By providing all the data, the rider acknowledges Yamaha Motor Europe to use the data for registration purposes under the laws of The Netherlands;
- b) You agree that any disputes in connection with the use of this information shall be resolved in court of competent jurisdiction in the Netherlands (principle place of business of Yamaha Motor Europe N.V.)
