

# The Good Guys Concierge and Hisense

## Try, Review, Keep Program

### Terms & Conditions

1. The Good Guys Concierge and Hisense Review (“Program”) is conducted by The Good Guys Discount Warehouses (Australia) Pty Ltd (ACN 004 880 657) of 60 City Road, Southbank VIC 3006 (The Good Guys).
2. Participation in the Program is deemed as acceptance of these Terms and Conditions.
3. Participation in the Program is only opened to The Good Guys Concierge Members who are residents in Australia and aged 18 years and over. Employees (and their immediate families) of The Good Guys and Hisense and employees of competitors of Hisense products are ineligible to apply. Competitors of Hisense products are defined as any company that sells or manufactures products in the same industry or product categories as Hisense and/or The Good Guys.
4. Applications open on 22/03/2021 and close 11.59pm AEDT 28/03/2021 (“Application Period”).
5. To apply, Concierge members must visit [www.thegoodguys.com.au/concierge-member-benefits](http://www.thegoodguys.com.au/concierge-member-benefits) and complete the application form during the Application Period. Applicants must provide information about themselves, complete a video audition and In 25 words or less tell us how the NEW Hisense 75Inch ULED 8K TV will upscale your TV entertainment at home.
6. If they are selected as a participant in the Program, they must submit a short written and video review.
7. Participant must submit their review between March – May 2021.
8. The Good Guys will select five [5] applicants to become participants in the Program for the Hisense 75Inch ULED 8K TV (Model: 75U80G). The Good Guys’ decision is final, and no correspondence will be entered into.
9. The Good Guys will review all applications for suitability for participation in the Program.
10. Incomplete, indecipherable or illegible applications will be deemed invalid.
11. 13. The selected participants will be provided with the Hisense 75Inch ULED 8K TV (Model: 75U80G) to complete a review.

14. The selected participants agrees to participate in the Program in consideration of receipt of the model allocated to them. During the Program, participants must use the Hisense 75Inch ULED 8K TV in accordance with its instruction manual in an ordinary domestic manner.
15. Selected participants will be contacted by The Good Guys Home Services Team to arrange delivery and installation of the Hisense 75Inch ULED 8K TV. Table top Installation will only be provided to participants who have an antenna and power point within one metre of where the TV will be located.
16. When the delivery & installation occurs, the Concierge Member needs to ensure that the area is clear and ready for installation to take place. Rubbish will be removed however old units will not be taken away.
17. Delivery time and location is agreed with the installer organised through The Good Guys Home Network Pty Ltd. Home Services Network Pty Ltd ABN 56 622 336 350 t/as The Good Guys Home Services (NSW Contractor Licence Number 319335C, QBCC Trade Contractor Licence Number 15086123, SA Building Work Contractor Licence BLD 286495, TAS Contractor Licence No. 15605877, NT Electrical Contractor Licence Number C3784), does not perform gas fitting, electrical or plumbing work. All gas fitting, electrical and plumbing work is performed by licensed subcontractors engaged by The Good Guys Home Services, and all required electrical and gas safety/compliance certificates are issued by these license subcontractors.
18. The Good Guys is not liable if the Hisense 75Inch ULED 8K TV cannot be delivered for any reason, such as access problems, if no person is at the delivery address on the day of delivery, or the delivery is cancelled by the member.
19. Applications will be judged in the week following the Application Period by The Good Guys at 60 City Road, Southbank VIC 3006 and the selected participants will be notified via email and/or phone.
20. Participant's full first name, surname initial and state will be published on The Good Guys website at [www.thegoodguys.com.au/winners](http://www.thegoodguys.com.au/winners) no later than 5 working days after the participant have been notified and for a minimum of 28 days.
21. Participant must submit their written and video review of the product within the advised time frame between March – May 2021. Participants warrant that they will respond honestly in relation to the product(s) they test, and any review provided will be a true reflection of the participant's opinion. Reviews can be positive or negative, and this will not impact a participant's ability to remain part of the Program or keep the product. The Good Guys shall not be liable in any way for such Content to the full extent permitted by law. The Good Guys may remove or decline to publish any Content without notice for any reason whatsoever.
