### SECTION 5 : Firefighting measures

#### Extinguishing media

**Suitable extinguishing agents:** Use appropriate fire suppression agents for adjacent combustible materials or sources of ignition. Water spray may cause frothing. For large fires, use water spray, fog or regular foam. Contact professional fire-fighters immediately. For small fires, use dry chemical, carbon dioxide, sand, earth, water spray or regular foam. **For safety reasons unsuitable extinguishing agents:**

#### Special hazards arising from the substance or mixture:

Thermal decomposition can lead to release of irritating gases and vapors.sulfur oxides. During a fire, irritating and highly toxic gases may be generated by thermal decomposition or combustion. Dust can be an explosion hazard when exposed to heat or flame. This material in sufficient quantity and reduced particle size is capable of creating a dust explosion. Flammable solid. May burn rapidly with flare burning effect. May re-ignite after fire is extinguished

#### Advice for firefighters:

**Protective equipment:** Use NIOSH-approved respiratory protection/breathing apparatus. Evacuate area and fight fire from a safe distance. As in any fire, wear a self-contained breathing apparatus in pressure-demand, MSHA/NIOSH (approved or equivalent), and full protective gear

**Additional information (precautions):** Move product containers away from fire or keep cool with water spray as a protective measure, where feasible.Use spark-proof tools and explosion-proof equipment.Avoid generating dust; fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard.Avoid inhaling gases, fumes, dust, mist, vapor, and aerosols.Avoid contact with skin, eyes, and clothing.

#### Methods and material for containment and cleaning up:

Keep in suitable closed containers for disposal.Wear protective eyeware, gloves, and clothing. Clean up spills immediately, observing precautions in the Protective Equipment section. Scoop up with a nonsparking tool, then place into a suitable container for disposal. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Collect solids in powder form using vacuum with (HEPA filter). Evacuate personnel to safe areas.
