UNIFORMED LOGO WEAR AND SCREEN-PRINTED CLOTHING AGREEMENT

Agreement made December 16, between the City of Sioux Falls, SD, (the City) and Brown & Saenger (the Contractor).

The parties to this Agreement, in consideration of the mutual covenants and stipulations set out herein, agree as follows:

Section One

Contractor agrees to provide Uniformed Logo Wear and Screen-Printed Clothing per RFP 15-0184. The Contractor agrees to the following conditions as outlined in the Request for Proposals (RFP) for Uniformed Logo Wear and Screen-Printed Clothing:

Billing:

The Contractor shall be able to process purchase orders, credit cards, and have the ability to accept electronic fund transfer from the City.

The Contractor shall invoice all orders by each City department.

All invoices shall be in U.S. currency.

Customer Service:

The Contractor shall provide a dedicated customer service representative who is familiar with all aspects of the City's requirements and conditions of the contract. The Contractor shall promptly notify the City if there is a change in a customer service representative.

Contractor shall make available to the City all assigned customer service representatives' phone numbers, email addresses, and fax numbers to all City departments.

The customer service representative shall, when requested, provide samples for fitting purposes to City departments.

Contractor shall meet with the contract administrator not less than twice per year to conduct a contract and performance review of the contract. The meeting will be in person with not less than two in-person meetings per year. The review will include, but is not limited to, a review of the pricing, delivery performance, customer service, and improving operational efficiencies.

Delivery:

The Contractor shall deliver all orders free of charge within the city limits.

The Contractor shall deliver all orders within 30 days or less or by a specified amount of time required by the City department.

Online Ordering System:

The Contractor shall provide to the City, free of charge, an online ordering website with pictures and contracted prices of the clothing products. The online ordering website shall have the ability to accept credit cards and purchase orders.

The Contractor shall be responsible for all management, set-up, and changes to the online ordering system.

Section Two

This contract is a fixed-price-with-adjustment contract. The initial contract prices are based on the prices submitted by the Contractor that are attached and made part of this Agreement as Exhibit A. The prices shall be firm for the first year of the contract. Price adjustments will be negotiated at the request of either party in the extension periods or through an adjustment clause.

The City must be notified in a timely manner of all price decreases.

Written requests for price changes in term contracts after the firm-price period must be submitted in writing to the City. Any increase will be based on the Contractor's actual cost increase only, as shown in written documentation. All requests for price increases must be in writing, must not constitute increases in profit, and must contain data establishing or supporting the increase in cost. At the option of the City: (1) the request may be granted; (2) the contract may be canceled and solicitation may be readvertised; or (3) the contract may be continued without change.

The City will accept or reject all such written requests within thirty (30) days of the date of receipt of Contractor's request for price increase and receipt of proper written documentation, whichever is later.

If a price increase is approved, the City will issue an amendment to the contract specifying the date the increase will be effective. Contractor will be required to send notice to all users of the contract. All products and related accessories are to be billed at prices in effect at the time the service was rendered or order was placed.

When the City rejects a request for a price increase, the Contractor will be notified and the contract will continue without change.

The Contractor shall provide a 20 percent discount on all clothing items carried by the Contractor not listed in Exhibit A.

Section Three

This Agreement shall terminate on December 31, 2018, with the option to extend the contract for no more than two one-year contract renewals or extensions.

Section Four

The Contractor shall be subject to the provisions of Chapter 98 of the Code of Ordinances of Sioux Falls, SD. It is declared to be discrimination for the Contractor, because of race, color, sex, creed, religion, ancestry, national origin, or disability, to fail or refuse to hire, to discharge an employee, or to accord adverse, unlawful, or unequal treatment to any person or employee

with respect to application, hiring, training, apprenticeship, tenure, promotion, upgrading, compensation, layoff, discharge, or any term or condition of employment.

If the Contractor is guilty of discrimination, this agreement may be terminated in whole or in part by the City, and the Contractor shall be liable for any costs or expense incurred by the City in obtaining from other sources the work and services to be rendered or performed or the goods or properties to be furnished or delivered to the City under the agreement so terminated or canceled.

Should the Sioux Falls Commission on Human Relations, in a proceeding brought as provided by the Revised Ordinances of Sioux Falls, find that the Contractor has engaged in discrimination in connection with this agreement and issue a cease and desist order with respect thereto, the City shall withhold up to fifteen percent of the contract price until such time as the commission's order has been complied with or the Contractor has been adjudicated not guilty of such discrimination.

The Contractor will permit access to any and all records pertaining to hiring and employment and to other pertinent data and records for the purpose of enabling the commission, its agencies, and representatives, to ascertain compliance with the above provisions.

This section shall be binding on all subcontractors or suppliers.

Section Five

The Contractor shall secure the insurance specified below. All insurance secured by the Contractor under the provisions of this section shall be issued by insurance companies acceptable to the City. The insurance specified in this section may be in a policy or policies of insurance, primary or excess. Certificates of all required insurance shall be provided to the City upon execution of this agreement.

1. Workers' compensation insurance providing the statutory limits required by South Dakota law. In addition, it shall provide Coverage B, Employer's Liability Coverage, of not less than \$1,000,000 each accident, \$1,000,000 disease-policy limits. The required limit may be met by excess liability (umbrella) coverage.
2. Commercial general liability insurance providing "occurrence form" contractual, personal injury, bodily injury, and property damage liability coverage with limits of at least \$1,000,000 per occurrence, \$2,000,000 general aggregate, and \$2,000,000 aggregate products and completed operations. The required limit may include excess liability (umbrella) coverage. The policy shall name the City and its representatives as an additional insured. If "occurrence form" insurance is not available, "claims made" insurance will be acceptable. The policy shall be maintained for three years after completion of this agreement.
3. Automobile liability insurance covering all owned, nonowned, and hired automobiles, trucks, and trailers. The coverage shall be as broad as that found in the standard comprehensive automobile liability policy, with limits of not less than \$1,000,000 combined single limit each occurrence. The required limit may include excess liability (umbrella) coverage.
4. Professional liability insurance providing occurrence-basis coverage for any claim arising from the errors, omissions, failure to render a service, or the negligent rendering of the service by the Contractor in the amount of \$1,000,000 each occurrence and \$1,000,000 annual

aggregate. If "occurrence form" insurance is not available, "claims made" coverage shall be maintained for two years after final completion of the services. The City does not represent that the above coverages and limits are adequate to protect the Contractor, and assumes no responsibility therefor.

The Contractor will provide the City with at least 30 days' written notice of an insurer's intent to cancel or not renew any of the insurance coverage. The Contractor agrees to hold the City harmless from any liability, including additional premium due because of the Contractor's failure to maintain the coverage limits required.

The City's approval or acceptance of certificates of insurance does not constitute City assumption of responsibility for the validity of any insurance policies, nor does the City represent that the above coverages and limits are adequate to protect any individual/group/business, or its consultants' or subcontractors' interests, and assumes no liability therefor.

Section Six

The funding being provided pursuant to this Agreement is an authorized budget item of the City of Sioux Falls for calendar year 2016. If the financial condition of the City should change during the term of this Agreement to the extent that the City would or might have insufficient yearly revenue to meet all of its budgeted expenditures, this Agreement may be modified and the funding provided for herein reduced by a percentage amount equal to the percentage amount by which the City's 2016 general fund operating budget is negatively impacted by spending restraints implemented at the direction of the City's Mayor. By way of illustration, if the Mayor would issue expenditure restraints reducing actual expenditures under the 2016 general fund operating budget by 15 percent, the funding provided for in this Agreement may also be reduced by 15 percent. Any reduction so imposed shall be at the sole discretion of the City.

Section Seven

If funds are not budgeted or appropriated for any fiscal year for services provided by the terms of this Agreement, this Agreement shall impose no obligation on the City for payment. This Agreement is null and void except as to annual payments herein agreed upon for which funds have been budgeted or appropriated, and no right of action or damage shall accrue to the benefit of the Contractor, its successors, or assignees, for any further payments.

Section Eight

The Contractor agrees to hold the City harmless from all claims or liability, including attorneys' fees arising out of the services furnished under this agreement, and for bodily injury or property damage arising out of services furnished under this agreement, providing that such claims or liability are the result of an act, error, or omission of the Contractor and/or its employees/agents arising out of the agreement.

Section Nine

The parties acknowledge that they are entering into this Agreement freely and voluntarily, that they have the opportunity to be represented and advised by counsel in the negotiations resulting in this Agreement, that they have ascertained and weighed all the facts and circumstances likely

to influence their judgment, that they have given due consideration to the provisions contained herein, and that they thoroughly understand and consent to all provisions herein.


Section Ten



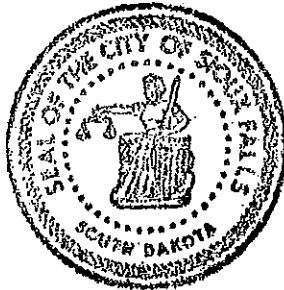


