

# IKEA Family Birthday offer: '\$10 off your next purchase when you spend \$50 or more' terms & conditions

- A \$10 birthday voucher will be issued to selected IKEA Family member to redeem when they spend \$50 or more in one transaction, instore or online by the 'valid to' date stated on the voucher. ## Redemption of \$10 birthday voucher

- To redeem the \$10 voucher instore, members must either present the original voucher email to an IKEA staff at checkout to scan or scan the QR code from the voucher email at the self-serve checkout, when they spend \$50 or more in one transaction, excluding delivered items.
- To redeem the \$10 voucher online, members must be signed into their profile, and enter the Promo code in the field box before proceeding to checkout.
