

So please get your coggins drawn early to allow processing time so that we don't have to refuse your participation on the day of a show or clinic.


Our first participating competition:

The meeting was called to order 8:01 at pm.

Sandy Toby made the motion to accept the minutes from the last meeting. Sherri Booye seconded, and the Board approved unanimously.

Treasurer's Report – Jessie has reported that are balances are around 148K.

GAIG/USDF Region 1 and VADA Fall Competition – IMPORTANT Date has changed to October 14-17. The show may be particularly large as this is the first year that juniors will have their own division at the US Finals for training thru 4th level.

2021 Williams/Warren Clinic: To be held June 26-27th. The rider application and informational flyer have been sent to chapters and are on the website. Rider applications are due electronically to Sheli by April 15th. All riders applying will be charged half of the fee plus a \$25 processing fee. If you are not chosen, the rider fee will be refunded but the \$25 processing fee will not. The \$25 can be used to cover one day of auditing. We will allow as many auditors as we can with COVID restrictions, and the live stream will be free for VADA members. The auditor application has not been dispersed yet.

2021 Officers: The slate of officers for the new year are the same officers from 2020. Bettina Longaker, President Sheli King, Vice- President Jessie Ginsburg, Treasurer Alison Douglas, Secretary. No other nominations were received. Sandy Toby made the motion to accept the new slate. It was seconded by Sherri Booye and passed with Tina, Sheli, Jessie and Alison abstaining.

Chapter Challenge- All chapters need to email Sandy Toby who their reps are for the committee. The show will be held August 21st at The Meadow in Doswell and we need a secretary. Chapters also need to email Sandy with their special awards.
