

Contest Official Rules:

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

This contest (the “**Contest**”) is sponsored by The Toro Company (“**Sponsor**”), 8111 Lyndale Avenue South, Bloomington, MN 55420.

1. Eligibility: The “Red White and Ag” Contest is open only to those who are 18 as of the date of entry, and who submit a photo according to the entry instructions in these Official Rules . Contest is only open to legal residents of the United States. Residents of Rhode Island and residents outside the United States are not eligible to win. The Contest is void where prohibited by law. Employees of Sponsor, its affiliates, subsidiaries and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Contest. The “Red White and Ag ” Contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

2. Agreement to Official Rules: By participating, the entrant (“You”) agree to be fully unconditionally bound by these Official Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of Sponsor as final and binding as it relates to the content of this Contest.

3. Contest Period: Entries will be accepted online starting July 1, 2018 PST at 12:00am PST and ending on August 31, 2018 at 6:00 pm PST. All online entries must be received by 6:00pm, August 31, 2018 PST.

4. How to Enter: The “Red White and Ag ” Contest must be entered one of two ways:

1. By sharing a photo on Facebook, Instagram or Twitter that includes the hashtag #ToroUSAg in the original post.
2. By visiting the contest webpage at driptips.toro.com/photo-contest and submitting your photo using the online submission form.

The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the Official Rules may be disqualified at the sole discretion of Sponsor. No limits on entries. One post with #ToroUSAg or one photo submitted using the online submission form counts as one (1) entry. If You use fraudulent methods or otherwise attempt to circumvent the Official Rules, your submission may be removed from eligibility at the sole discretion of Sponsor.

5. Photo Requirements. Photos may not contain any content that: (a) is not an original photograph taken by You; (b) appears to duplicate any other submitted entry; (c) depicts product usage contrary to its operating instructions posted warnings, or otherwise depicts any activity that may appear unsafe or illegal; (d) is defamatory, disparaging, derogatory, profane, obscene, or sexually suggestive; (e) depicts or promotes alcohol, drugs, tobacco, or firearms; (f) promotes any political agenda or message; (g) infringes upon copyrights, trademarks, rights of privacy, publicity or other intellectual property of any person or entity; (h) contains any personal or private information; (i) depicts without permission another person's name or likeness; or (j) violates any law. You must obtain any consent necessary to permit the use and exhibition of the entry by Sponsor in the manner set forth in these Official Rules, including, without limitation, permission from any person who is identifiable in the entry. Failure to provide proof of these permissions upon request may render the entry null and void.

6. Prizes: The Winner of the "Red White and Ag " Contest (the "Winner") will receive a Yeti Cooler (approximate \$500 retail value). Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by Sponsor. No cash or other prize substitution shall be permitted. The prize is nontransferable. Sponsor will deliver the prize to the Winner at a location within the United States to be specified by Winner. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. 8. Winner Selection, Notification, and Prize Delivery: On or about September 10, 2018, Sponsor will select one (1) winner ("Winner"). Photo entries will be judged based on productivity shown, image quality, image beauty, and uniqueness. If no qualifying entries are submitted, no winner will be announced. . Winner will be notified by social media message or by email within five (5) days following selection of Winner. Persons may obtain Winner's name by going to the Contest Site or mailing a self-addressed stamped envelope to the Sponsor. Sponsor will not respond to requests received after September 15, 2018. Sponsor shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 30 Days from the time award notification was sent, or fails to timely return a completed and executed Affidavit as required, the prize may be forfeited and an alternate Winner selected. Receipt by Winner of the prize offered in this Contest is conditioned upon compliance with any and all federal, state, and local laws and regulations. If your entry infringes upon the intellectual property right of another, You will be disqualified at the sole discretion of Sponsor. If the content of your entry is claimed to constitute infringement of any proprietary or intellectual proprietary rights of any third party, You shall, at your sole expense, defend or settle against such claims. You shall indemnify, defend, and hold harmless Sponsor from and against any suit, proceeding, claims, liability, loss, damage, costs or expense, which Sponsor may incur, suffer, or be required to pay arising out of such infringement or suspected infringement of any third party's right.

Terms & Conditions: Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Contest should virus, bug, non-authorized human intervention, fraud, or other cause beyond Sponsor's control corrupt or affect the administration, security, fairness, or proper conduct of the Contest. In such case, Sponsor may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Sponsor. Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Contest or website or violates these Official Rules. Sponsor has the right, in its sole discretion, to maintain the integrity of the Contest, including, but not limited to disqualifying entries for: the use of bots, macros, scripts, or other technical means for entering. Any attempt by an entrant to deliberately damage any website or undermine the legitimate operation of the Contest may be a violation of criminal and civil laws. The releases hereunder are intended to apply to all claims not known or suspected to exist with the intent of waiving the effect of laws requiring the intent to release future unknown claims.
