- (b) There should not be any adverse remarks in work load returns circulated by various appropriate authorities in MES, or known from any other sources.
- (c) Bid capacity as worked out by the following formula shall be more than estimated cost of work.

Bid capacity = AxN-B

Where

A= Average annual turnover pof last 3 financial years

N= Period of completion of contracted work (in years calculated till 2 decimal places).

B= Valve of balance work in running Govt. contracts for above period.

- (c) Form should be profit making.
- (d) These contractors shall also require to submit notarized copy of valid passport of proprietor/each partner/each director.
- (C) All the tenderers / bidders shall note that uploading of copy of Provident Fund Code No in addition to the other documents as stated above in technical bid (Cover 1) is mandatory. The bidders who will not upload Provident Fund Code No his bid shall be disqualified and his financial bid shall not be opened

- 1. The Contractors enlisted in one class below the Eligible class given above may also submit bids. The Accepting officer may consider such bids in case of inadequate response from eligible class contractors.
- Tenders not accompanied by requisite value DD/Bankers Cheque towards cost of Tender and other documents shall be rejected. Demand draft/Bankers cheque and other documents as notified in NIT shall reach GE (AF) HASIMARA before stipulated date of opening of bid failing which bids of concerned bidders rejected and necessary disciplinary action shall be initiated against the defaulting firms.

- 8. If original DD of un- enlisted contractors is not received within 5 days from the last date of bid submission, the cover 1 ('T' bid) shall not be validated for opening of financial bid. Name of such contractors alongwith complete address shall be circulated for not opening of bid for the period of SIX MONTHS commencing from the date of financial opening.
