
Miller Permanent Roof Anchors

PERMANENT ROOF ANCHOR

The Miller Single D permanent roof anchor is designed to provide one (1) D-ring anchorage point when securely installed on a wood roof sub-surface or vertical wall.

Accommodates single user up to 310 lbs. (140.6kg) for fall protection.

PERMANENT ROOF ANCHOR

The Miller Double D permanent roof anchor is designed to provide two (2) D-ring anchorage points when securely installed on a wood roof sub-surface.

Accommodates single user up to 310 lbs. (140.6kg) for fall protection.

Meets OSHA 1926.502 guideline.


PERMANENT ROOF ANCHOR The Miller Claw permanent roof anchor is designed to provide a single anchorage point when securely installed on a wood rafter or truss member. The Claw anchor fits wood sizes 2" x 4", 2" x 6", 2" x 8", 2" x 10" or 2" x 12".

Accommodates single user up to 310 lbs. (140.6kg) for fall protection.
