

# User's Guide to Foot Pedals for Advantage2 Keyboards\*

## Single Pedal (FS007RJ11)

## Triple Pedal (FS007TAF)

*\*also works with Advantage keyboards with different actions:  
For FS007TAF, Left pedal=Keypad Enter, right pedal=Shift.*

### Connecting pedal to keyboard

Connect the telephone-style pigtail on your keyboard's main cable to the matching coupler that came with your foot pedal (figure 1, arrow).

**Warning:** Do not connect foot pedal to any telephone line or other equipment accepting RJ11 plug. Doing so could create an electrical or fire hazard.

### Default actions

**Single Pedal (FS007RJ11).** “Keypad Shift” action. Shifts keyboard into keypad mode while the pedal is pressed.

### Triple Pedal (FS007TAF)

**Left:** “Tab” action.

**Middle:** “Keypad Shift” action. Shifts keyboard into keypad mode while the pedal is pressed.

**Right:** “Keypad Enter” action.

### Anchoring single pedal to floor

If you have an individual pedal, you may find it easier to use if it is anchored to the floor with the provided self-adhesive hook & loop square. If you are working on carpet, just use the “hook” side attached to the bottom of the foot switch.

### Customizing pedal actions

These foot pedals actions can be customized to perform any action that a key with your Kinesis Advantage2 keyboard, using the SmartSet™ Programming Engine.

Program a new action to a pedal the same way you re-program a key. Like a key, a pedal has the ability to perform a different action when the keyboard is in “keypad mode.” See your keyboard's User's Manual for details.
