## Information for the User

### Safety Notices

#### USA—FCC and FAA

The FCC with its action in ET Docket 96-8 has adopted a safety standard for human exposure to radio frequency (RF) electromagnetic energy emitted by FCC certified equipment. The wireless adapter meets the Human Exposure limits found in OET Bulletin 65, supplement C, 2001, and ANSI/IEEE C95.1, 1992. 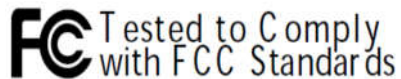

### Antenna Placement

- To comply with RF exposure requirements the antenna(s) used with the wireless adapter must be installed to provide a minimum separation distance from all persons in all operating modes and orientations of the host platform as specified by the FCC grant conditions. 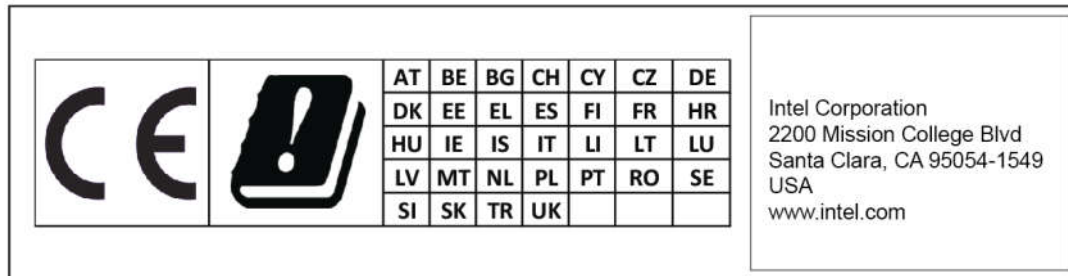
