**OUT OF STATE COUNSEL'S VERIFIED MOTION

subject to any order of discipline or disability by any Bar, or had any request for *pro hac vice* admission denied or revoked.


4. Mr. Zomer has not previously sought *pro hac vice* admission in Colorado.
