

EXECUTIVE DIRECTOR'S REPORT TO THE PORT OF PORTLAND COMMISSION FOR AUGUST 2019

SAFETY REPORT

Port of Portland July 2019 safety performance resulted in a lower frequency of injuries and claims reported compared to July 2018. There were five total reported incidents in July 2019, and of those incidents, three resulted in claims and two are Occupational Safety and Health Administration recordable cases, including one involving lost time and one involving restricted time.

Monthly Report of Injury Incidents

<u>Aviation</u>

One lost-time recordable injury incident:

 Maintenance worker strained lower back moving an 8-inch diameter, 100-foot-long temporary water hose that still contained water. Investigation revealed that proper pretask planning was not conducted to identify and correct risk factors. Worker attempted to manually move a heavy object without assistance from others who were being made available. Worker received medical treatment, has recovered and returned to work.

Navigation


One restricted-time recordable injury incident:


Navigation worker was performing a pipeline drill to add a section of pipe. While rotating
a pipe coupling ring, the worker strained their right wrist. Investigation revealed potential
opportunities for improvement of task safety. Worker received medical treatment, is
recovering and has returned to work.

Public Safety & Security

One non-recordable injury incident:

 Police Officer was performing a home search when the homeowner knocked over a container of isopropyl alcohol which splashed into the Police Officer's face, resulting in a burning sensation in the eyes. Police Officer immediately flushed eyes and face, which successfully treated the symptoms.

<u>Passengers</u>

With the Boeing MAX grounding (impacting American and Southwest at PDX) and seasonal service cuts by Alaska, Frontier and JetBlue, total passengers are down 3.0 percent from budget and prior year actuals.

Concessions Rent

The reported 2.3 percent, or \$38,000, rent decrease from last year is 0.6 percentage points above the 2.9 percent passenger decrease on the month, and includes a net increase of \$6,000 in rents produced from facilities not open both years. The food and beverage coffee category produced the highest category increase on the month with a 1.7 percent increase compared to July 2018.

Rental Car Rent

Rental car operations reflect a 3.4 percent, or \$94,000, rent increase over last year for the month of July, against an enplanement decrease of 2.5 percent. Avis was the top performing brand, reporting a 9.0 percent increase compared to July 2018.

Parking Revenue

Public parking revenue decreased 2.7 percent compared to July 2018. The long-term and economy products were down in revenue, but the premium short-term and valet products increased revenue over July 2018. Transactions decreased 4.1 percent, with all products reflecting negative transactions. This information suggests that travelers parking in the short-term garage and valet are staying longer month over month. This is also reflected in additional reports that show the short-term garage is seeing a trend in fewer one- to three-hour meeter/greeter customers, but more four- to eight-hour customers.

Ground Transportation

Transportation Network Company (TNC) trips still dominate the ground transportation landscape. The TNC PIN/Code pilot continued through July.

While ground transportation volumes are up, significant portions of traffic around the hold lot and Airport Way/82nd Avenue are a result of regional Oregon Department of Transportation construction, including several on- and off-ramp closures, and detours onto 82nd Avenue. The Port hired flaggers to assist with traffic management and this effort has improved operations at the intersections.
