The Bridge Network is a new product being offered to self-funded employer groups for which EmblemHealth and CCI will be providing administrative services and access to our commercial networks. Bridge Plan members do not need to elect a primary care provider and no referrals are required to access specialists. Below is key information you will need to recognize these new members, coordinate care and bill for services.
