## NOTICE OF AIRPORT/HELIPORT ALTERATION (AV-19) INSTRUCTIONS

### REFERENCES:

- A. Aviation Code, Act of October 10, 1984, P.L. 837, No. 164
- B. Department of Transportation Aviation Regulations, Chapter 471, Title 67, PA Consolidated Statutes. §471.7 (Licensing Criteria and Requirements) (b)(2) An owner or operator of an airport shall give prompt written notice to the Bureau, using Bureau Form AV-19, of a proposed physical change in the airport that is likely to affect its safety or conformity with the criteria under which the airport was licensed by the Bureau.
- C. FAA Advisory Circular 150/5300-13 (Airport Design) (as amended)
- D. FAA Advisory Circular 150/5390-2 (Heliport Design) (as amended)

### PURPOSE:

Use this form to report significant changes to the airport/heliport. Changes to runways and heliports may require a Bureau inspection to assure compliance with licensing guidelines.

### INSTRUCTIONS:

#### Sponsor Information

1. List the airport/heliport name in the top block as it appears on the license.
2. Enter the name, mailing address, and phone number of the airport/heliport owner/sponsor.

#### Alteration/Change

1. Provide a brief description of the proposed alteration for the airport/heliport. Attach an airport/ heliport sketch plan or diagram that details the change(s).
2. Changes to a runway or heliport landing area will require an on-site inspection. Attach an inspection fee of \$50 paid to the Commonwealth of Pennsylvania (check, money order or bank draft). Any additional site or re-inspection may require an additional \$50 inspection fee.

#### Change of Based Aircraft

1. If additional aircraft are to be based at the site, provide the make, model and registration information of each new aircraft. Attach the take-off and landing performance specifications for each aircraft.

#### Certification

The owner, or authorized agent for the owner, must sign and date the application. Print or type the signatory's name. If appropriate list the signatory's title.
