Preface


The survey was designed to discover more about the key themes emerging from early engagement and research in the MAPs programme, and allow us to hear views of PAs, AAs and doctors during the initial lockdown when our planned face to face engagement had to be paused.

It was live between $8 - 29^{th}$ June and promoted to the MAPs community of interest (a mix of PAs, AAs, doctors and others who are interested) but members were also free to distribute the link to interested colleagues.

The data presented here is for all respondents and includes quantitative data only. We're carrying out further research to understand differences of experience/opinion between respondent groups, and to explore free text comments in more detail in a series of focus groups. We'll share the findings from this work when it's complete.

We would like to thank everyone who took part for sharing their views and valuable time to contribute to this programme of work.




In your current role or a recent post, have you worked with and/or supervised AAs/PAs? Please select all that apply




Are you currently employed?



Which of the following best describes the setting(s) you currently work in? Please select all that apply.










Do you think it is appropriate that PA/AAs adhere to the same professional standards as doctors in the four broad areas discussed above?




Do you feel that there are any unique or additional professional issues that we need to focus on when adapting Good medical practice to the work of PAs and AAs in the following areas?




