



# CASE STUDY CONTEST

Jesse and Daniel are the winners of November Case Study based on most correct diagnosis and treatment plan:

**Jesse** "Rhythm is a-fib with anterior lateral MI, patient would get O2, IV, a 250cc bolus in attempt to get his BP up, nitro will be withheld until BP is appropriate, Opiates also withheld due to BP, helicopter launched if weather permits, emergent transport to nearest facility and cardiac alert called in. In route, serial EKGs, 2nd IV access obtained with blood draw and I-stat if time permits."

**Daniel** " A--Cardiogenic or obstructive shock secondary to AMI, pericarditis/pericardial tamponade, or PE; High index of suspicion for MI P--Request ALS intercept code 3. Assess for signs of chest trauma. O2 @ 15 lpm via NRB, titrate to SpO2 > 90%; prepare to provide PPV. Place combo pads. Move to ambulance, minimizing pt exertion. Warm pt and pt compartment, place Lucas back plate under pt. Start emergent transport. Request aircraft to receiving facility. Place ETCO2 NC. Check for unequal radial pulses. Obtain BGL. Ask about food allergies, possible poisoning. If pt still alert and no s/s of GI bleed or stroke, administer aspirin for daily dose to total 324mg. Establish two large-bore IV's. Draw bloods and bolus 10ml/kg NS. Ask about prescribed nitro; if prescribed, systolic > 90mmHg, and no ED medications within 72 hours, obtain verbal order to assist pt with sublingual nitro .4mg every 5 minutes, max of 3 doses. If time permits, obtain 12 lead and iStat labs for ED. Notify receiving facility of possible MI at ETA 10-15."

## **The Interpretation**

- Atrial fibrillation with rapid ventricular response: The rhythm is irregularly irregular at an increased rate with no discernible P-waves.
- **Probable fusion complex**: QRS #7 looks like a fusion complex with a PVC—note the subtle change in morphology that QRS shows in aVR and V5. Since the initial depolarization is fairly normal and the terminal QRS is narrow, I suspect a PVC from the right ventricle.
- O The last two QRS complexes look a little funky too, but it's much harder to make a case for fusion with such subtle changes
- O **Right bundle branch block**: The QRS duration is approximately 170 ms with a typical RBBB morphology in V1 and V6.

O **Probable left anterior fascicular block**: The initial QRS vector is tricky to calculate here. The RBBB delays depolarization in the right ventricle, producing a large, unopposed vector to the right and/or superiorly. That RV depolarization dominates the last 2/3 of the QRS and isn't clinically useful. To work around that, we only measure the first 40-60 ms of the QRS since that's when we can see the left ventricle depolarizing most clearly. With that in mind, I think there is left axis deviation. LAFB would also account for the short R-waves in the left precordial leads, and it fits with the rest of the ECG and clinical picture.

O Marked ST-elevation in I, aVL, and V2: We will discuss this in a moment, but it's indicative of myocardial injury. Marked ST-depression in II, III, and aVF: We'll cover these reciprocal changes as well.

•While it's correct to say that this pattern shows an "anterolateral" STEMI, we can go one step further: •This tracing is pathognomonic of acute left main coronary artery

## occlusion

•*It's* a STEMI of the left main coronary artery.

Dispatched to 70 year old female conscious and breathing found by family on the floor of her bedroom. Unknown time down.


U/A: Patient was found on the floor of her house by her family. The last time she had been seen was sometime the morning previous (>24 hours). She complained of feeling drowsy when the family talked to her yesterday on the phone. Airway – clear & paten Breathing – regular, shallow, 12 RPM SpO2% 86% @ room air BP 168/92 Circulation – Pulse weak at 52, regular, 12 lead below; skin color pale, cap refill delayed (>2 sec) Pupils PEARRL, size 4 BGL 64 Disability – LOC before ambulance arrival (according to family); patient responsive to pain on arrival. Oriented to self, unable to verbalize other orientation or event guestions.

Physical examination Pt is semi-dressed, incontinent of feces and urine, lying prone on the floor. Patient pale, dry, cold to touch. Physical exam unremarkable, pt is able to follow commands, but is slow to respond.

Temperature 29.6°C oral

CC pt is unable to verbalize a complaint

History: No known allergies. Currently taking calcichew, xanax, atenolol. History of HTN, detached retina.







# **Disaster Relief Team**


Captain Brian Gourdin is putting together a disaster relief team .This team will combine

# IT IMPORTANT INFO

Keep Yourself and GCEMS Protected against Spam and Viruses!!!!! SonicWall Threat Research Lab came across a recent spam email campaign sending fake invoice payment receipt emails in large numbers. Email messages claim that payment has already been made from the user's account or the payment has been scheduled to debit their account. This creates anxiety to open the attachment for more details.

#### Here is how it works:

Spam Email  $\rightarrow$  PDF attachment  $\rightarrow$  PDF has link to Office Doc  $\rightarrow$  Office Doc has Macro  $\rightarrow$  Macro runs script  $\rightarrow$  Script runs system command  $\rightarrow$  System Command downloads Malware  $\rightarrow$  Malware downloads more banking malware.

It all happens in an instant, then it's too late. An example of this malware is called EMOTET which is a 'dropper' that installs more malware.

#### Think Before you Click:

Do you know the sender?

Is the email you received actually from the sender? (verify the email address is correct and not a masquerade)

Were you expecting an attachment, does the sender normally invoice/notify in this manner?

Is the email worded appropriately?

Did you call the sender to verify its authenticity?

If you are unsure - stop and call Information Systems. Andrew, Mark, Eric and I would be glad to assist. If you are interested in more information or a more visual expiation, please contact me directly.

"It's Holiday Season for the bad guys too! They go into scam-overdrive mode. Black Friday and Cyber Monday are the busiest on-line shopping days of the year and bad actors are out to get rich with your money. So what to look out for? At the moment, there are literally thousands of fake sites, looking just like the real thing. Don't fall for it. Make sure the site you go to is the real one.

Type in the address or use your bookmark, do not click on links in emails with special offers.

Watch out for alerts via email or text that you just received a package from FedEx, UPS or the US Mail, and then asks you for some personal information. Do not enter anything. Know what you ordered, and be aware of how and when it will arrive. Fake 'Track your delivery' message are on the rise!

Don't download fake mobile apps that promise big shopping savings, and be very wary of online discount coupons. Think Before You Click! So, especially now, the price of freedom is constant alertness and willingness to fight back. Remember to only use credit cards online, never debit cards. If you think you might have been scammed, stay calm and call your credit card company, nix that card and get a new one. Happy Holidays!"

WTF do I do with all this leftover turkey" Turkey Quesadillas with Cranberry Salsa

Here is an amazing recipe from one of our amazing Captains Melissa Lewis.

## Ingredients

- 3/4 cup fresh or frozen cranberries
- 2 tablespoons sugar
- 1/4 cup water
- 1 small pear, chopped
- 1/4 cup chopped red onion
- 1 jalapeno pepper, seeded and chopped
- 3 tablespoons chopped celery
- 2 teaspoons grated lemon zest
- 1 tablespoon lemon juice
- 1/2 teaspoon ground cumin
- 4 flour tortillas (6 inches)
- 2 cups cubed cooked turkey breast
- 1 cup shredded reduced-fat white or yellow cheddar cheese



## Directions

For salsa, in a small saucepan, combine cranberries, sugar and water; bring to a boil. Reduce heat to medium; cook, uncovered, until berries pop, about 10 minutes, stirring occasionally. Remove from heat; cool slightly. Stir in pear, onion, jalapeno, celery, lemon zest and juice, and cumin.

Preheat griddle over medium heat. Top one half of each tortilla with 1/2 cup turkey; sprinkle with 1/4 cup cheese. Fold tortilla to close. Cook on griddle until golden brown and cheese is melted, 1-2 minutes per side. Serve with salsa.

## LIFEPACK to ESO

All the data on the monitor should be a part of the patient record. When you transfer the data to your report you will need to review all the VS that are imported and delete any of them that you do not believe to be accurate. Reminder anytime the alarm goes off the monitor time stamps that event and will transfer

data.

By January 1, 2019 you must transfer all data to your ESO report. So start practicing now. Melissa Sent out an email with a PDF outlining how to complete this. If you have any questions please talk to the Captain on shift.


