- Support community events and volunteer opportunities

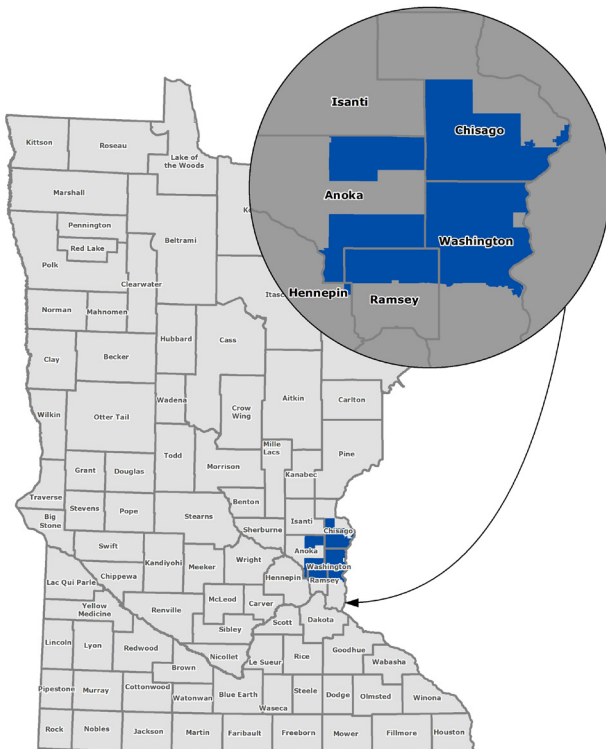
