- Return this completed form, including the serial number label, along with a copy of your invoice with the purchase price circled.
IMPORTANT: You must cut out and include the original label from the carton, which includes the UPC code, model number and serial number, or your registration cannot be processed.
- Offer valid for purchase made from January 12, 2012 – February 7, 2012. All registrations must be postmarked within 30 days of purchase.
- This offer is only available to the end user and original purchaser. No registration from resellers, dealers/distributors, their employees or warehouse facilities, groups, clubs or organizations will be accepted or acknowledged.
- Product must be new and un-used. No B-Stock Product allowed.
