INSTALLATION

The display should be installed near an easily accessible AC power outlet.

- Do not install the display face up or down, upside down or on its side.
- Do not install the display in hot, oily, humid, or excessively dusty places.
- Do not install the display in places subject to extreme temperature, such as in direct sunlight, near a radiator or a heating vent. The display may overheat in such conditions which can cause deformation of the enclosure and/or display malfunction.
- Do not install the display in a place exposed to direct air conditioning; moisture may condense inside and may cause display malfunction.
- Do not install the display where it may be exposed to mechanical vibration.
- Do not install the display where insects may enter.
- Do not install the display in a location where it may protrude, such as on or behind a pillar, or any place you might bump your head or receive bodily injury.

- Do not drop or place heavy objects on the power cord. If the power cord is damaged, turn off the power immediately. It is dangerous to use the unit with a damaged power cord.

On Installation

- Allow adequate air circulation to prevent internal heat build-up.
 - Do not place the unit on surfaces (rugs, blankets, etc.) or near materials (curtains, draperies) that may block the ventilation holes.
- Do not install the unit in a location near heat sources such as radiators or air ducts, or in a place subject to direct sunlight, excessive dust, mechanical vibration or shock.

When installing the installation space must be secured in consideration of the ventilation and service operation.

Connecting to Other Devices

When connecting this unit to other devices, turn off this unit and the other devices beforehand.

Connecting while turned on may cause a malfunction to this unit and the other devices.

Handling the Screen

- The LCD panel fitted to this unit is manufactured with high precision technology, giving a functioning pixel ratio of at least 99.99%. Thus a very small proportion of pixels may be "stuck", either always off (black), always on (red, green, or blue), or flashing. In addition, over a long period of use, because of the physical characteristics of the liquid crystal display, such "stuck" pixels may appear spontaneously. These problems are not a malfunction.
- Do not leave the screen facing the sun as it can damage the screen. Take care when you place the unit by a window.
- Do not push or scratch the display's screen. Do not place a heavy object on the display's screen. This may cause the screen to lose uniformity.
- If the unit is used in a cold place, horizontal lines or a residual image may appear on the screen. This is not a malfunction. When the display becomes warm, the screen returns to normal.
- The screen may become warm during operation. This is not a malfunction.

On a Long Period of Use

Due to an LCD's panel structure and characteristics of materials in its design, displaying static images for extended periods, or using the unit repeatedly in a high temperature/high humidity environments may cause image smearing, burn-in, areas of which brightness is permanently changed, lines, or a decrease in overall brightness.

In particular, continually displaying an image smaller than the displaying area, such as an image in a different aspect ratio or with a frame, may expedite the above issues.

Avoid displaying a still image for an extended period, or using the unit repeatedly in a high temperature/high humidity environment such an airtight room, or around the outlet of an air conditioner.

To prevent any of the above issues, we recommend reducing brightness slightly, and to

turn off the power whenever the unit is not in use.

On Dew Condensation

If the unit is suddenly taken from a cold to a warm location, or if ambient temperature suddenly rises, moisture may form on the outer surface of the unit and/or inside of the unit. This is known as condensation. If condensation occurs, turn off the unit and wait until the condensation clears before operating the unit. Operating the unit while condensation is present may damage the unit.

On Watching 3D Video Images

Some people may experience discomfort (such as eye strain, fatigue, or nausea) while watching 3D video images or playing stereoscopic 3D games. Sony recommends that all viewers take regular breaks while watching 3D video images or playing stereoscopic 3D games. The length and frequency of necessary breaks will vary from person to person. You must decide what works best. If you experience any discomfort, you should stop watching the 3D video images or playing stereoscopic 3D games until the discomfort ends; consult a doctor if you believe necessary. You should also review (i) the instruction manual of any other device or media used with this product and (ii) our website (http://www.sony.com/support) for the latest information. The vision of young children (especially those under six years old) is still under development.

Consult your doctor (such as a pediatrician or eye doctor) before allowing young children to watch 3D video images or play stereoscopic 3D games. Adults should supervise young children to ensure they follow the recommendations listed above.

Handling and Maintenance of the Screen

The surface of the screen is specially coated to reduce image reflection. Make sure to observe the following points as improper maintenance procedures may impair the screen's performance. In addition, the screen is vulnerable to damage. Do not scratch or knock against it using a hard object.

- Do not throw anything at the display as the impact can cause the screen glass to crack, break, or scatter.
- Be sure to disconnect the AC power cord from the AC outlet before performing maintenance.
- The surface of the screen is specially coated.
 Do not attach adhesive objects, such as stickers, on it.
- The surface of the screen is specially coated. Do not touch the screen directly.
- Wipe the screen surface gently with the supplied cleaning cloth to remove dirt.
- Stubborn stains may be removed with the supplied cleaning cloth slightly dampened with a mild detergent solution.
- The screen may become scratched if the supplied cleaning cloth is dusty.
- Never use strong solvents such as alcohol, benzene, thinner, acidic or alkaline detergent, detergent with abrasives, or chemical wipe as these may damage the screen.
- Use a blower to remove dust from the screen surface.

On Transportation of the Unit

- If the unit is transported or moved in a wrong way, the unit may fall over and cause an injury such as a bruise or fracture.
- Hold the unit securely as seen in the following illustration.



- Do not press or put pressure on the screen when holding the unit.
- Disconnect the AC power cord and all cables connected to the unit before transporting the unit.
 - If the unit is transported with the AC power cord connected, the AC power cord may be damaged and cause a fire and electrical shock.
- When transporting the unit for repair or moving, pack the unit using the original carton box and packing materials.
- Do not subject the unit to severe vibration or high impact conditions during transportation.
 Doing so may result in deformation of the internal structure or exterior of the unit,

damage of the screen, malfunction of the internal parts, or other damage. Make sure not to expose the unit to strong vibration or high impact when you transport the unit as cargo by truck, ship, or air, or as luggage with a rolling luggage bag.







- View the unit avoiding direct outside light on the display.
 - Stereoscopic images may not be viewable due to the light reflected on the display.
- Do not place the unit in an environment where the eye-sensing sensor is facing a light source.
- The unit displays an optimized image by detecting the viewer's face and recognizing the eye-gaze of the viewer with the eye-sensing sensor. Take off masks and hats when viewing the unit.
- The unit has been designed for users to view images by placing it horizontally. If the unit is placed vertically, you cannot view images in 3D.
- When the viewing image is unstable, adjust the viewing environment including the installation position.
 - The eye-sensing sensor may be having difficulty recognizing your eye-gaze.



Location and Function of Parts and Controls

Front



1 ∪ (Power) switch and indicator

Press to turn on the unit.

The indicator lights in white when the unit enters the operating state.

Press again to turn off the unit and indicator.

2 MENU button

Press to turn on/off the on-screen menu. When the on-screen menu is displayed, press to move the cursor to select a menu item.


3 +/- button

Press to adjust the volume. When the on-screen menu is displayed, press to change the setting value of the menu item (page 15).

4 Eye-sensing sensor

Detects the viewer's face and recognizes the eye-gaze of the viewer.





Check the position, shape, and orientation of connectors on the rear of the unit.





Connecting the HDMI Cable

Connect the HDMI input connector of the unit and the HDMI output connector of your computer with the supplied HDMI cable.



- Directly connect to the computer without using an HDMI switcher or other devices.
- Check the position and orientation of the connector and cable before connecting the cable to the connector.
- Before connecting, make sure the HDMI connector supported by your computer supports HDMI 2.0 or higher to ensure the original image can be displayed on the unit. For details, see the operating instructions for your computer.

Connecting the USB Type-C Cable

Connect the • (Communication control) connector of the unit and the USB connector of your computer with the supplied USB Type-C cable.




Connecting the AC Adaptor

Attaching Accessories


Stereoscopic images can be viewed easily with naked eyes by attaching accessories which may bring about a stronger sense of immersion. Make sure to attach accessories when viewing the unit.

- **1** Attach the bottom stand.


Insert the tab of the bottom stand into the space under the bottom of the unit and push the bottom stand until it stops.



2 Attach the side panels.


Remove the protection film on the side panels, then place the side panels on the display as seen in the following illustration with the glossy side facing inward toward the screen.

The side panels attach to the display panel with the magnets on the bottom of the side panels.



3 Attach the top flange.

Insert the top flange into the space between the side panel and display panel as seen in the following illustration.







2 Press the MENU button to select the menu item.

The selected item goes down from the top by pressing the MENU button.

3 Press the +/– button to change the values and settings.

The adjusted values and settings are stored automatically.

When changing the value:

Press the + button to increase the value. Press the – button to decrease the value.

When selecting the setting:

Press the +/- button to select the setting.

To clear the menu

If you press the MENU button while selecting the menu item at the very bottom, "Information screen" appears.

Press the MENU button again to clear the screen. Also, the menu screen disappears automatically if you do no operate the menu for a while.
