**A RESOLUTION OF THE BOARD OF TRUSTEES OF THE TOWN OF HOT
SULPHUR SPRINGS, COLORADO RATIFYING BOARD OF TRUSTEES
CONSENT TO THE MAYOR'S ISSUANCE OF AN EMERGENCY
DECLARATION AND ITS CONTINUATION UNTIL REPEALED BY THE
BOARD OF TRUSTEES**

WHEREAS, on March 17, 2020, pursuant to authority granted to the Mayor of the Town of Hot Sulphur Springs, Colorado, as the Town's principal executive officer under the Colorado Disaster Emergency Act, C.R.S. § 24-33.5-701 *et seq.*, the Mayor issued a declaration of local disaster in the Town of Hot Sulphur Springs, Colorado, as a result of the occurrence of imminent threat of widespread or severe damage, injury, or loss of life or property, due to the presence and spread of Coronavirus Disease 2019 (COVID-19) ("Declaration"); and

WHEREAS, the Board of Trustees provided consent to the adoption of the Declaration and any continuation or renewal thereof on March 18, 2020 at its public meeting; and

WHEREAS, the Board of Trustees desires to ratify and affirm its consent to the issuance of the Declaration effective as of March 18, 2020 and its continuation until repealed by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF HOT SULPHUR SPRINGS, COLORADO THAT:

Section 1. The Board of Trustees hereby approves and ratifies its consent to the issuance of the Declaration including the authorized extension thereof attached hereto as Exhibit A and its continuation until repealed by the Board of Trustees. All actions taken by the Mayor in issuing such Declaration and its continuation after March 18, 2020 are hereby authorized.

Section 2. **Effective Date.** This Resolution shall be deemed effective upon approval by Board of Trustees.

TOWN OF HOT SULPHUR SPRINGS DECLARATION OF LOCAL DISASTER EMERGENCY DUE TO CORONAVIRUS DISEASE 2019 (COVID-19)


Authority: This declaration is issued pursuant to authority granted to the Mayor of the Town of Hot Sulphur Springs, Colorado ("Hot Sulphur Springs") as the principal executive officer of Hot Sulphur Springs under the Colorado Disaster Emergency Act, C.R.S. § 24-33.5-701 et seq..

Declaration: I declare there to be a local disaster in the Town of Hot Sulphur Springs, Colorado, to wit, the occurrence of imminent threat of widespread or severe damage, injury, or loss of life or property, due to the presence and spread of Coronavirus Disease 2019 (COVID-19). The effect of this declaration shall be, as necessary to cope with this incident, to:

1. Activate the response and recovery aspects of emergency operations plans and any applicable inter-jurisdictional disaster emergency plans applicable within the Town;
2. Authorize the furnishing of aid and assistance under such plans;
3. Authorize the requesting of aid and assistance from appropriate agencies;
4. Authorize emergency procurements; and
5. Authorize cooperation and coordination with federal, state and county emergency agencies and public health agencies regarding response, recovery and mitigation efforts.

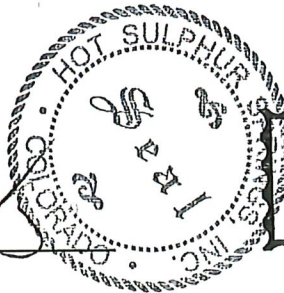
This declaration shall expire in 7 days unless renewed by the Board of Trustees. This declaration shall be recorded with the Town Clerk and distributed to the Board of Trustees, Grand County, the Colorado Division of Emergency Management, and appropriate representatives of the news media.
