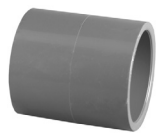

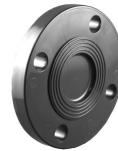

SOLVENT WELD CONNECTIONS

Use a quality grade of primer and solvent cement formulated for the type of connection, with the correct size applicator. Read and follow all of the solvent cement manufacturer's application instructions.

THREADED CONNECTIONS

Use a quality grade of Teflon® tape. The use of Teflon® paste, pipe joint compounds, or other thread lubricants is not recommended as they may contain substances that are harmful to plastics.

1 to 1½ turns beyond finger tight is generally all that is required to make a sound plastic threaded connection. Unnecessary over-tightening will cause damage to both pipe and fitting.

Limited Warranty

Charlotte Pipe and Foundry Company® (Charlotte Pipe®) Products are warranted to be free from manufacturing defects and to conform to currently applicable ASTM standards for a period of five (5) years from date of delivery. Buyer's remedy for breach of this warranty is limited to replacement of, or credit for, the defective product. This warranty excludes any expense for removal or reinstallation of any defective product and any other incidental, consequential, or punitive damages.

This limited warranty is the only warranty made by seller and is expressly in lieu of all other warranties, express and implied, including any warranties of merchantability and fitness for a particular purpose. No statement, conduct or description by Charlotte Pipe or its representative, in addition to or beyond this Limited Warranty, shall constitute a warranty. This Limited Warranty may only be modified in writing signed by an officer of Charlotte Pipe.

This Limited Warranty will not apply if:

- 1) The Products are used for purposes other than their intended purpose as defined by local plumbing and building codes, and the applicable ASTM standard.
- 2) The Products are not installed in good and workmanlike manner consistent with normal industry standards; installed in compliance with the latest instructions published by Charlotte Pipe and good plumbing practices; and installed in conformance with all applicable plumbing, fire and building code requirements.

- 9) Pipe outlets, sound attenuation systems or other devices are permanently attached to the surface of Charlotte® PVC, ABS or CPVC products with solvent cement or adhesive glue.
