

Polycom IP Phone Bundle Rebate

How to Participate

Step 1 Purchase at least 5 SoundPoint IP desktop phones and one SoundStation IP conference phone from a certified Polycom reseller between July 1, 2010 and December 31, 2010.

Step 2 Submit completed Polycom IP Phone Rebate Bundle claim form, proof of purchase, and customer invoice or receipt via mail, fax or email as directed on the claim form. All claim forms must be submitted within 30 days of purchase.

Step 3 Polycom will issue each rebate check directly to the End User customer within 6 weeks of receiving qualified and verified claims.

Claiming Multiple Rebates: One \$200 rebate may be claimed for every 5 to 1 ratio of SoundPoint IP desktop phones to SoundStation IP conference phones purchased on the same order, with no limits. For example:

- 20 SoundPoint IP and 4 SoundStation IP purchased qualifies for 4 rebates (\$800 total)
- 50 SoundPoint IP and 2 SoundStation IP purchased qualifies for 2 rebates (\$400 total)
- 50 SoundPoint IP and 15 SoundStation IP purchased qualifies for 10 rebates (\$2,000 total)

Any mix of SoundPoint IP desktop phone models and SoundStation IP conference phone models qualify.

1. End Users must purchase at least 5 new Polycom SoundPoint IP desktop phones and one SoundStation IP conference phone from a certified Polycom Channel Partner to be eligible for this rebate program. Used products do not qualify.
2. Multiple rebates may be claimed for products all purchased on the same invoice, but only one rebate will be paid for each combination of 5 SoundPoint IP desktop phones and one SoundStation IP conference phone.
3. Required documentation includes: completed **Claim Form, proof of purchase, and reseller invoice**. Proof of purchase is white product label with product serial number from outside of each SoundPoint IP and SoundStation IP box. Photocopies of proof of purchase are acceptable.
4. **Rebates checks will be issued and sent directly to the End User.** If a customer, such as an education or state entity, is unable to accept rebate checks directly from Polycom, a check may be issued to the reseller. In this case, the reason must be documented on the Claim Form and authorized by the End-User customer. The reseller must provide the **rebate in advance to the End User customer. The reseller invoice must include a line item deduction off the total invoice amount** for the full rebate amount to validate the up front rebate was given.
5. The End User will be sent an email confirmation when their claim is received. Polycom is not responsible for lost or misdirected shipments, email, mail or faxes.
6. Polycom has the right to call the End User at any time for verification purposes.
7. This offer is only available to End User customers who purchase from a certified Polycom Channel Partner.
8. This offer is void where prohibited or otherwise restricted by law. Rebates will be sent within 6 weeks of receiving all the necessary documentation (completed Claim Form, proof of purchase and customer invoice or receipt).
9. Program valid July 1, 2010 through December 31, 2010 or until terminated by Polycom.
