


# **SUPPORT**



### Repair / Reset

If you cannot access the web-based setup page or cannot connect to the router, you can press the **Reset** button:

- Press and hold for 3 seconds and then release to repair your network. The light will turn blue and flash slowly until your network recovers.
- Press and hold for 10 seconds, and then release to reset the router to factory settings. The light will turn blue and flash rapidly. All data will be cleared when the light becomes solid blue.
