Xylem Water Solutions UK Ltd.'s Tanker brokerage services provide registered waste carrier facilities with trained and qualified personnel and a modern fleet of tankers to suck out waste liquor from sumps and tanks, transport the waste liquor to a registered disposal site and dispose of the material in an efficient and responsible manner. The entire transaction includes a complete waste transfer record.

The disposal of any waste material which is unpleasant or controlled carries a responsibility for the site owner/operator to ensure that the waste is handled correctly and disposed of and treated properly. #### Case Study

A Client is provided with an ad-hoc cess pit emptying service. The Cess Pit is heavily sludged and the Xylem Service removes and records the volume and nature of removed waste.

Xylem issues a Waste Transfer Note for the collected volume to the Client and then proceeds to a registered disposal site. On Disposal, a further Waste Transfer Note is issued for the disposed volume.

The Client has a complete and reliable record of what volumes were collected and disposed through registered facilities and avoids any investigations into the potential 'fly tipping' of waste material.

#### Price

You pay for a visit and the removal and disposal of up to 1000 gallons as a fixed charge. In the event that the volumes exceed 1000 gallons then additional charges for disposal will apply.
