

## Official Sweepstakes Rules "\$25K Giveaway. Test Drive Select Models and Get a Chance to Win' ("Sweepstakes")

## 1. Method of Entry:

Step 1: Go to your participating authorized Brother Innov-ís Sewing and Embroidery Dealer ("Dealer") and take a 20 minute machine demonstration ("Demonstration") on one of the following new Brother machines: Innov-ís NX2000 (MSRP \$2,999.95), Isodore™ Innov-ís 5000 (MSRP \$8,299.95), Quattro® 2 6700D (MSRP \$9,999.95), Entrepreneur® PR650e (MSRP \$10,499.95) or Entrepreneur® Pro PR1000e (MSRP \$14,499.95).

Step 2: After the Demonstration, the Dealer will give you a scratch off card which contains a unique code ("Code") that will provide access to enter the Sweepstakes online.

Step 3: Go to www.brother25k.com where you will be prompted to enter your Code online. After the Code is verified, the entry form will prompt you for your name, address, telephone number and email address and then ask you to submit your entry into the Sweepstakes.
