The equipment are Bluetooth Serial Module with integrated antenna and Bluetooth Serial Module with surface mount pad for external antenna (BT Module), intended for used with information technology equipment.

The equipment was evaluated for use in a maximum air ambient of 85°C.

Overall dimensions of the equipment were approximate 12.5 by 17.3 mm.
