

HOW TO SUBMIT A REBATE.

1) Print the Mail-In Rebate Form from My Documents and Receipts in My Verizon.

- Print the corresponding rebate form for each rebate-eligible wireless number.
- **Note:** Rebate form will not be available in My Verizon after postmark deadline.

2) Cut the Bar Code Label from the outside of the manufacturer's box that your equipment came in.

- Include the entire original white bar code label from the box.
- The bar code label must include the Device ID (ESN, MEID or IMEI) bar code and the Proof of Purchase (UPC) bar code.
- The Proof of Purchase (UPC) number on the bar code label must match the Valid UPC shown on the rebate form.

Bar code label examples (varies by manufacturer):



3) Confirm the postmark date on the rebate form.

- Your rebate submission must be postmarked by this date.

4) Confirm your name, email and mailing address on the rebate form.

- This is the name that will appear on the rebate card.
- If you need to make changes, please use the space provided.

5) Sign and date the rebate form.

6) Make a copy of your rebate submission items for your records:

- Mail-In Rebate Form
- Bar code label

7) Mail the rebate form and original bar code label to the address shown on the form.

- **IMPORTANT:** Your rebate submission must be postmarked by the date shown on the rebate form.
- Only submit one rebate request per envelope.

CÓMO SOLICITAR UN REEMBOLSO.

1) Imprime el formulario de Reembolso por Correo desde *Mis Documentos y Recibos* en Mi Verizon.

- Imprime el formulario de reembolso correspondiente a cada número de móvil que califique para un reembolso.
- **Aviso:** El formulario de reembolso no estará disponible en Mi Verizon después de la fecha límite del sello postal.

2) Recorta la etiqueta del código de barras ubicada en el exterior de la caja fabricante en que vino tu equipo.

- Incluye toda la etiqueta original blanca del código de barras de la caja.
- La etiqueta del código de barras debe incluir el código de barras de identificación del aparato (ESN, MEID o IMEI) y el código de barras de prueba de compra (UPC).
- El número de prueba de compra (UPC) en la etiqueta del código de barras debe corresponder al UPC válido que aparece en el formulario de reembolso.

Ejemplos de la etiqueta del código de barras (varían según el fabricante):



3) Confirma la fecha del sello postal en el formulario de reembolso.

- Tu solicitud de reembolso debe llevar el sello postal antes de esta fecha.

4) Confirma tu nombre, dirección de correo electrónico y dirección postal en el formulario de reembolso.

- Éste es el nombre que aparecerá en la tarjeta de reembolso.
- Si necesitas hacer cambios, por favor usa el espacio provisto.

5) Firma y fecha el formulario de reembolso.

6) Haz una copia para tus archivos de los siguientes artículos de la solicitud de reembolso:

- Etiqueta del código de barras
