One full set of shipping documents (invoice/packing list/delivery note/physical photo) shall be emailed to STS at least 14 days prior to goods arrival at Hongkong in order to apply for import license in advance.

RISK

For shipments under "DAP Shenzhen STS plant" terms, supplier shall bear all risks up to arrival of cargo at Shenzhen STS plant, irrespective of which transport service is used to deliver the goods.

ROUTING

Any hand-carry (bypassing Customs declaration via FFTZ gate 1, gate 2 or gate 3) is forbidden for shipment to Shenzhen STS wherever it's from mainland China or from overseas.

All oversea shipments (with invoice/packing list/delivery note attached) shall be delivered to Hongkong before being transported to STS plant through "Gate 1" between Hongkong and Shenzhen Fu Tian Free

Trade Zone. Direct shipment delivery is not allowed to any place of mainland China, namely it's prohibited to deliver any shipment directly to Shenzhen airport or seaport.

- 14). For FOC and/or Warranty shipments, the intended recipient of STS shall be indicated on invoice and packing list or delivery note, along with either "FOC" or "Warranty" remarked on each item. (FOC shipments must be separated from others in terms of package)
- 15). For Wafer/Dice shipment, both wafer quantity and dice quantity must be indicated on invoice and packing list.

One full set of shipping documents (invoice, packing list and/or delivery note) shall be put into a pouch attached to the parcel/carton. These documents shall physically accompany the shipment and shall be handed over to DTW Hongkong.

Chemical goods shall be labeled in English and Chinese with an attached MSDS (material safety data sheet) in both languages.

Supplier shall indicate the packing material and country of origin clearly in the shipping documents; otherwise supplier shall be responsible for the incurred losses.

All information must be exactly aligned and reconciled among supplier's documentations, customs certification/license and physical goods. Any liability due to violation/inconsistency must be borne by the supplier, for instance risk of customs fines.

WOODEN PACKING MATERIALS

Wooden packing materials from any country shall require heat treatment or fumigation and shall be stamped with "IPPC" mark on each outer crate or each pallet before shipment from country of origin, irrespective of the solid wood size.

PAYMENT

After GOODs delivered or Service rendered to STS and proper invoice received by STS accounts payable team, a payment will be remitted in line with payment term to your official bank account, Supplier shall be responsible for communicating its correct bank information duly authenticated by his company representative.
