

NXP Semiconductors 2021 Retiree Open Enrollment

Action is not required as there are new plans for 2021. **Open Enrollment for 2021 must be completed online**.

We are pleased to provide the following information about the 2021 Open Enrollment for the NXP Semiconductors medical, dental and vision benefit plans. During the open enrollment period, November 2-13, you can make changes to your RETIREE coverage elections, including enrolling in, cancelling or changing coverage without a qualifying event. This is the only scheduled time during the year in which you can enroll in or make changes to your RETIREE benefits.

Our records indicate that you are enrolled in RETIREE Plan. Please read the following information to determine your options during this open enrollment period.

You will be required to remit your payment by the date indicated on the RETIREE premium invoice in order for your coverage to be effective and accessible on January 1, 2021.
