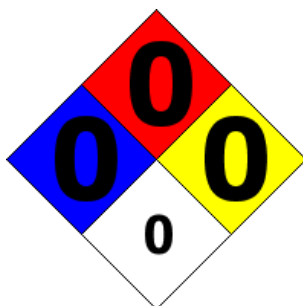

### SECTION 4 : First aid measures

#### Description of first aid measures

#### Precautions for safe handling:

#### Appropriate Engineering controls:
