As a medical device manufacturer and importer into the EU market, ResMed Pty Ltd and all its European Business Units ("ResMed") understand the obligations to register with the European Chemicals Agency (ECHA) and to facilitate the flow of information in the supply chain for any articles containing SVHCs on the Candidate List in a concentration above 0.1% weight by weight.

ResMed works closely with all our vendor partners and suppliers to ensure that we are compliant and transparent on any qualifying articles and provide this information to the best of our knowledge. The list we provide below is continuously monitored and updated when the information is available and we continue to work with our vendors as our portfolio changes and as the Candidate List is updated.
