### **SOUND** DEVICES

### About Ambisonics

An ambisonic recording uses a multi-capsule microphone to capture a spherical representation of sound from a single point.

Ambisonic recordings are captured in A-Format or B-Format.

A-Format is the raw audio captured from each capsule on the microphone.

B-Format is the decoded audio, representing the sperical sound space with 4-channels, W, X, Y, Z:

- W = Sum of all signals from all directions
- X = Front minus rear signal
- Y = Left minus right
- Z = Up minus down

B-Format comes in two versions, with different orderings of the formatted channels:

- FuMa = W,X,Y,Z
- AmbiX = W,Y,Z,X



### **Recording Ambisonics**

To use the Ambisonics Plugin, you will need an ambisonics microphone, such as the Sennheiser AMBEO. The MixPre must be set to Advanced Mode, with a bit depth of 16 or 24. Ambisonics is not supported with 32-bit float depth. Sample rates of up to 192 kHz may be recorded, but binaural monitoring is not supported above 48 kHz.

The Ambisonics Plugin may not be used in combination with other plugins, such as the Musician or MixAssist Plugins.

### **INSTALLING AND ACTIVATING THE PLUGIN**

1. Visit the Sound Devices Store to purchase the Ambisonics Plugin. 2. Download the license—a .LIC file—and transfer to an SD card. The license file may only be used once.

3. Insert the SD card into the MixPre and turn on the recorder.



5. Navigate to System > Plugins.

6. Tap Apply Plugins. This installs the license, activates the plugin, and reboots the device.

### **ENABLING AMBISONICS**

1. Navigate to Inputs > Ambisonics.

2. Select the desired Mode. [Off, A -> B (AmbiX), A->B (FuMa), A->B(AmbiX + FuMa), A (Direct), A (Direct) + AmbiX, A (Direct) + FuMa, B (AmbiX), B (FuMa)]

3. Select the Mic Position. [Up, Down, Endfire]

4. In the menu screen, tap

5. Select LR Stereo or Binaural monitoring.

6. Plug in the ambisonics microphone according to the manufacturer's instructions.

7. Enable phantom power and set appropriate gain on channel 1. Channels 1-4 are automatically linked.

8. Arm channel 1 when ready to record.

### **RECORDING MULTIPLE FORMATS**

- 1. Navigate to Menu > Record.
- 2. Select Rec L,R to record a stereo WAV.
- 3. Select Rec Binaural to record a binaural WAV.

The MixPre-6 and MixPre-6 II can record one ambisonic format (such as A->B (AmbiX)) and a stereo WAV and/or a binaural WAV. If two ambisonic formats are being recorded (such as A->B (AmbiX+FuMa)), it is not possible to record a stereo WAV/binaural WAV.

The MixPre-10T and MixPre-10 II can record up to two ambisonic formats, a stereo WAV, and a binaural WAV file simultaneously.








### Files

When recording multiple formats or a stereo/binaural WAV, the MixPre will store each file separately, with a unique suffix:

- LR is the decoded stereo mix.
- AmbiX is the decoded AmbiX B-Format.
- FuMa is the decoded FuMa B-Format.
- Bin is the decoded binaural file.
- A\_Fmt is the raw A-Format file.
