

#### What Are Dissolved Solids

- TDS is a combination of inorganic substances (salt, metals, and other elements) that are dissolved in tap water and can leave an undesirable taste.
- TDS comes from both natural deposits and man-made sources, including: road salts, old piping, leaves, etc.
- The FDA requires Purified Bottle Water to achieve a TDS reading between 000-010 pp/m. Typical TDS in U.S. tap water is 240pp/m.
- TDS levels in U.S. tap water can measure over 400pp/m. What level of TDS does YOUR tap water have?






## FIND TDS IN YOUR NEIGHBORHOOD

Seeing the TDS level can help you know the quality of water you are drinking. A higher level of TDS indicates a higher level of dissolved solid and artificial taste. Lower levels of TDS indicate few substances & a more pure taste.

## A TDS meter will show your tap water reading





ZeroWater uses a 5-stage Dual Ion Exchange filtration system, a process traditionally utilized in commercial water purification. This technology enables ZeroWater to remove 99.63% of the dissolved solids that traditional filters leave behind.

Zero TDS does not mean ALL substances are removed from your tap water, for removal of specific substances you should rely on third party certifications.


