- Applicants must be incoming Northland Community and Technical College (NCTC) students for the fall of 2017, 18 years of age or older.
- Applicants must succeed in the Digi-Key sales scholarship application/interview process.
- Applicants must plan to pursue (continue) a two year business (marketing/sales/accounting, etc.) or other company-approved Associate-level degree.

Requirements:

- Recipients must maintain a 2.5 grade point average (GPA) per semester to be eligible for partial (50% per academic year) tuition reimbursement.
- Recipients must commit to work part time at Digi-Key while enrolled in the program, maintain satisfactory performance and follow all pertinent company policies.
- Upon graduation from the program (degree must be completed within two academic years), the recipient will be eligible for a full time sales representative position at a higher rate of pay and with eligibility to participate in Digi-Key's comprehensive benefits program. Factors considered for full time employment include academic and work performance, good attendance and adherence to Digi-Key policies during the scholarship program.
