


Insert the Grand Theft Auto IV disc into the disc slot with the label side facing upwards. Select the \bowtie icon from the XMBTM Menu and press the \boxtimes button to continue. Make sure there is enough free space on the Hard Disk Drive (HDD) before commencing play. Do not insert or remove peripherals once the power is turned on.





SIXAXIS™ Menu Location

SIXAXIS™ controls are located in the controls section of the pause menu. Selecting SIXAXIS™ brings up a submenu which allows the player to enable motion controls for various actions.

SIXAXIS™ Features

Helicopter

- Pitch the controller up / down to control the pitch of a helicopter.
- Roll the controller left / right to bank a helicopter.

Bike

- . Roll the controller left / right to steer a bike.
- . Pitch the controller up to pull a wheelie.
- Pitch the controller down to do a stoppie.

Boat

- Roll the controller left / right to steer a boat.
- Pitch the controller up / down to control the trim of a boat.

Vehicle After-Touch

• Pitch and roll the controller to help control the orientation of vehicles in mid-air.

Reload

Quickly Pitch the controller up and then down to reload a weapon.

Darts / Bowling

Turn SIXAXIS[™] controls on / off for darts and bowling activity.

Auto Calibrate Pitch

When this option is enabled, upon entering a vehicle the current pitch of the SIXAXIS[™] is used as the central pitch position for all vehicle controls. Hold the controller at a comfortable angle when entering vehicles to calibrate the controller to your preferred playing position.

Tinderbox Avenue between Phalanx Road and Julin Avenue •


Dry humping might be free on the subway, but there is no better way to unwind at the end of a hard day than a lap dance.

Bismarck Avenue, between Ruby Street and Quartz Street . Lancaster, Algonquin






69TH Street Diner
