

2020 Virtual Event/Live Demo Series Promotion Terms and Conditions



This promotion is being offered by Juniper Networks ("Juniper"). By participating in this promotion, all participants are bound by and agree to these official rules.

No purchase necessary. This promotion is open only to legal residents of the fifty (50) United States and the District of Columbia who are twenty-one years of age or older and who are eligible to participate in our 2020 virtual events & live demo series promotion pursuant to the conditions set forth herein. This promotion is void everywhere outside the U.S. or where prohibited by law or participant's corporate or business policies.

Government and state employees, and "foreign officials" are prohibited from participating in this promotion or from accepting any giveaways under this promotion, even if invited by Juniper to participate in this promotion.
