

INSTAGRAM CONTEST RULES TEMPLATE

Hot Wheels™ id Challenge Contest Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR TO WIN. MANY WILL ENTER; FEW WILL WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

- 1. ELIGIBILITY:** The Hot Wheels™ id Challenge (the “**Contest**”) is open to legal residents of the 50 United States and the District of Columbia who are 18 years of age or older and who have a registered Instagram account as of the beginning of the Contest Period (defined below). Employees (their immediate families, including parents, spouses, children, siblings and grandparents, and household members, whether or not related) of Sponsor, their advertising or promotional agencies, those involved in the production, development, implementation or handling of the Contest, any agents acting for, or in behalf of the above entities, their respective parent companies, officers, directors, subsidiaries, affiliates, licensees, service providers, prize suppliers, any other person or entity associated with the Contest (collectively, “**Contest Entities**”), are NOT eligible. To enter the Contest: (i) Visit a participating Target Retail Location, and download the exclusive digital unlock *Digital Hiway Hauler 3.0™* on your Hot Wheels™ id application. With this specific digital unlocked vehicle, the first person to race, win and post a screenshot and tag #HotWheelsid and @hotwheelsofficial on Instagram as proof that you won 150 Races will win the grand prize. By posting onto your personal Instagram account as mentioned above you are automatically entered into the Contest. Entries must be received before the end of the Contest Period to be eligible for the Contest. [Limit one Contest entry per person for the duration of the Contest] Use of multiple Instagram accounts and/or email addresses by the same individual to enter is prohibited. Use of computer programs and/or other automated devices to enter the Contest is prohibited. Normal Internet access and usage charges imposed by your on-line service will apply and are your responsibility.
- 4. Contest DRAWING NOTIFICATION:** One (1) potential winner will be selected by Hot Wheels® Social Media team whoever is the first person to complete and win 150 races and post a screenshot and tag #HotWheelsid and @hotwheelsofficial on Instagram from among all eligible entries received during the Contest Period. This decision will be made in conjunction with Consumer Relations Social Group, Digital Engagement Group, and Hot Wheels Global Brant Team, whose decisions are final on all matters related to the Contest, within five (5) days after the Contest Period ends. Potential winner will be notified on Instagram via private message and given instructions on how to contact Sponsor through email to claim their prize. The potential winner (or potential winner’s parent/legal guardian if the potential winner is a minor in his/her state of residence) must reply to the winner notification from Sponsor and include his/her mailing

address and/or email address (or the mailing and/or email address of the potential winner's parent/legal guardian if the potential winner is a minor) within forty-eight (48) hours.
