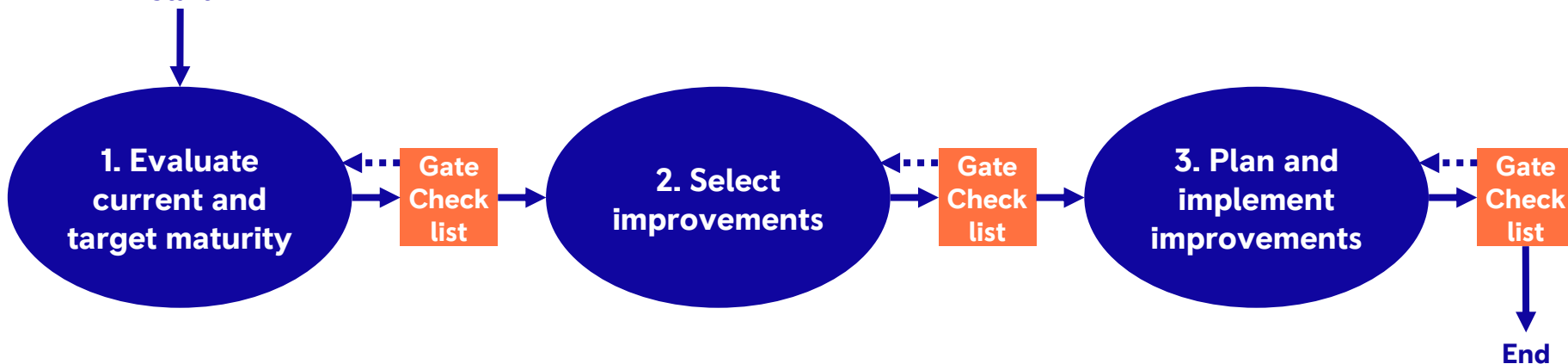

A methodology to **select 'How-tos'** prioritised for maturity gap closure

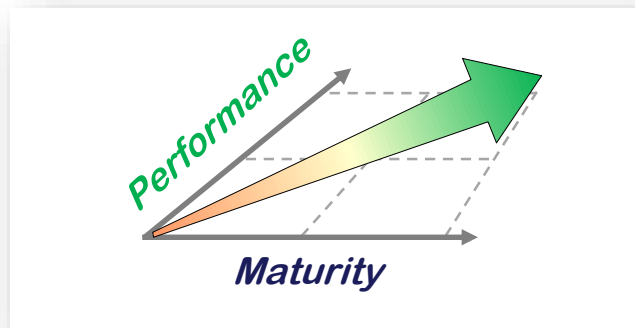
A structured approach to **planning** improvement activity and **manage implementation**

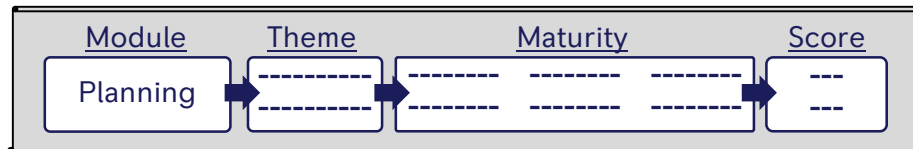
- Apply a maturity assessment as a standard approach to define both the current and target situation

- Apply an easy-to-use self-assessment founded on a lean approach - Tools-Systems-Principles
- Use the assessment to prioritise action and track improvement over time - Plan-Do-Check-Act



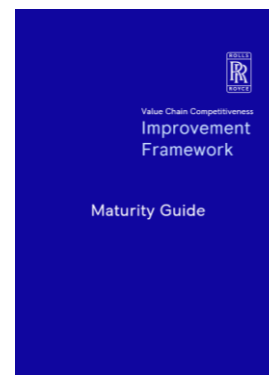
1. Evaluate current and target maturity



- Evaluate using a standard Maturity Assessment through 'self assessment'



- Structured in 20 **themes** across the 6 **modules**
- Each theme has a **maturity** definition section and a scoring section
- Maturity statements enable selection of the maturity **score**
- Use the **Maturity Guide** to assist in the assessment process



Module: Leading Improvements

To ensure that we behave and lead in the right way to empower and engage people to focus on the continuous improvement of processes, products and services to the customer.

Theme: Goal Deployment

- Give a **common direction** and drive responsibilities
- System to enable **coaching** of principles, processes and tools
- Leadership actions** enabling a continuous improve culture

Theme: Performance Management

- Connect** business and local goals
- Visually manage** performance
- Measures that engage** and drive improvement thinking and problem solving

Theme: Continuous Improvement

- What is **value-added** and waste?

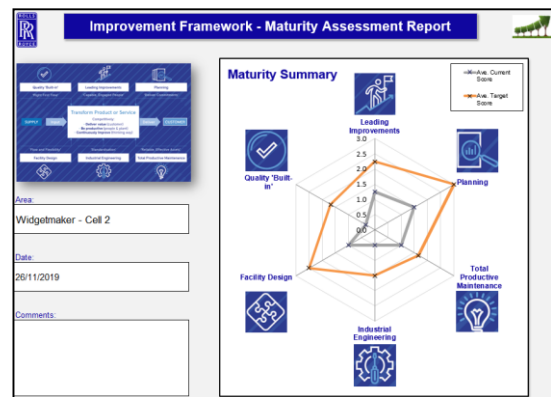
Use the Maturity Assessment tool to capture the information and maturity scores.

1. Evaluate current and target maturity



Considerations for completing the Maturity assessment:

- Assessment approach - understanding and buy-in
- Scope - area for assessment / no. of assessments
- Team members - with required knowledge
- Preparation - assessment familiarisation
- Method for current state - Go-Look-See to confirm the actual condition with a current maturity score
- Method for target state - how to position the target condition, both timing and target score agreement
- Management - ownership of the assessment and update process

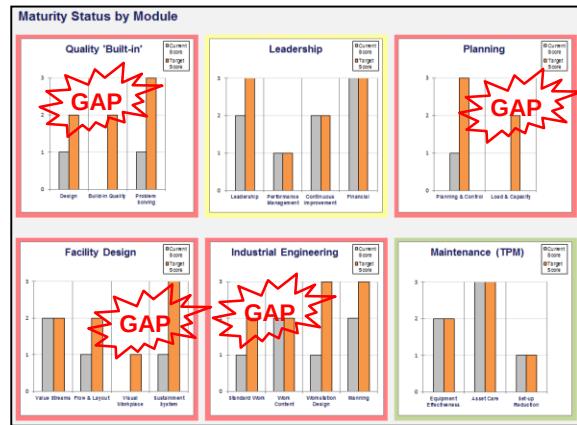

2. Select improvements



The Maturity assessment tool enables improvements to be selected using the framework 'How-tos' provided

- The 'assessment' theme status and 'report' charts visually indicate gaps in maturity
- Where gaps exist, use the How-tos to develop an understanding and activity required to close the gaps
- Record the improvement activity required in the 'Actions / Comments' section
- Red / Amber / Green assists in identifying gaps

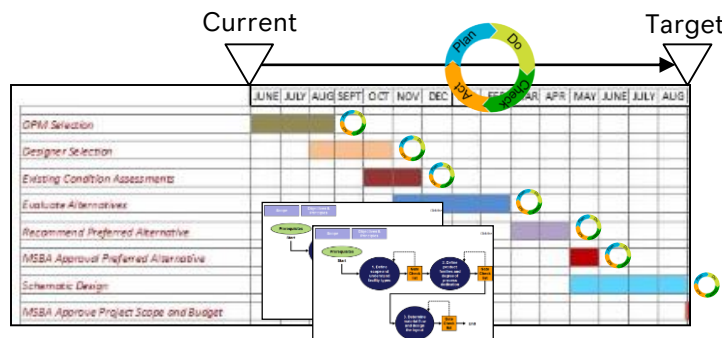
Plan activities using selected improvements and knowledge to reach the identified target

Implement activity and review using plan status and maturity assessment reporting tool

Plan-Do-Check-Act for the next agreed target condition

Use the completed maturity assessment to develop the plan

- Define improvement activities using the selected how-tos - mindful of timing, cost and resource
- Ensure the plan has commitment
- Ensure the activities incorporate Plan-Do-Check-Act to sustain improvements through frequent progress reviews
- Implement the plan - celebrate wins and successes
- Track progress through maturity and performance update and
- Repeat towards the next agreed target condition
