Payment Terms

- We gladly accept the following methods of payment: Checks, Money Orders, and Credit Cards (MasterCard®, Visa®, American Express®, and Discover®).

- Payment is due 30 days from invoice date unless otherwise noted on the front of the invoice.

- Minimum order: Product orders totaling \$100.00 or less are assessed a minimum order fee of \$10.00. Fee is excluded on purchases by the U.S. Military only. (Web orders excluded)
