REVENUES

Sales and Lodging taxes, Building and Short-Term Rental fees, and Highway Users taxes are all expected to be lower than originally budgeted for 2020. Sales taxes are projected to be 95% of the budgeted level and Lodging taxes are projected to be 80% of the annual budget. Building permits are projected to be 80% of the original budget amount. Short-Term Rental renewals are projected to be 100% of the budgeted level. Highway User Taxes are projected to be slightly lower than budgeted for 2020. Airport reimbursements for projects are projected to be increased from 95% to 100% of costs. Federal Cares Act reimbursements for COVID 19 expenses estimated to be \$700k.

WHEREAS, the FBI's Internet Crime Complaint Center (ICJ) reported more than \$3.5 billion in losses to individual and business victims in 2019 due to cybercrime (any crime which is committed electronically) with over \$65 million in losses within Colorado; and

WHEREAS, Grand County's residents are encouraged to do their part in increasing cybersecurity awareness and training by visiting the Cybersecurity & Infrastructure Security Agency (CISA) website and reviewing the publications posted; and

WHEREAS, residents are encouraged to pass along these invaluable cybersecurity tips to their friends, family, and coworkers; and

WHEREAS, Grand County's Information Security staff are dedicated to assisting the public through prevention and protection education; and

WHEREAS, the 2020 National Cyber Security Awareness Month theme, "Do Your Part. #BeCyberSmart" serves to remind us that we all have a part in protecting each other from cyber threats.

NOW THEREFORE, be it resolved the Board of County Commissioners of the County of Grand, State of Colorado, do hereby proclaim October 2020, as Cyber Security Awareness Month in Grand County, and encourage residents to participate by taking cybersecurity training, using safe online practices, reaching out for help when needed, and to support awareness by sharing what we have learned with others.

Commissioner Manguso announced that the Board is sitting as the Board of Health.

Public Health Director Brene Belew-LaDue stated that rates have increased over the last two weeks. Grand County was at a safer at home level 2 concern and is now at level 3 high risk.

Over the last seven months, the quarantine and isolation orders were 295 people and over the last two weeks it has been 203 quarantine and isolation letters.

Ms. Belew-LaDue will be hiring a half time contact tracer.

Ms. Belew-LaDue's department has worked on a number of new outbreaks.

Dr. Selenke stated that she would like to have the community look at COVID in the same manner as they look at wildfires. Dr. Selenke asked people to take all the recommended precautions – wear masks, wash hands, socially distance, and don't go to work sick.

Commissioner Manguso announced that the Board is sitting as the Board of Commissioners.

GC Veterans Service Office – Geographic Distribution of VA Expenditures

Grand County Veterans Service Officer Duane Dailey presented the GDX (Geographic Distribution of Veteran Expenditures).

For fiscal year 2019, the VA funds 256 medical clients to Denver. That amount care amounts to \$3.6 million in care delivered to Grand County residents.

The total veteran population that receives service connection disability, non-service connected pension, and DIA for widows for Grand County for 2019 was \$7.3 million. That is up from \$5.2 million just the year before.

Mr. Dailey stated that 746 veterans are receiving benefits in Grand County. That does not include a DOD retiree.

Grand County Library District Update, Community Needs Assessment

Grand County Library District Executive Director Polly Gallagher stated that the District started the Community Needs Assessment in April.

There was an on-line survey where they had well over 400 respondents with survey data that they were able to use. There were different focus groups. One group was heavy library users, one was citizens that do not use the library much and one group was the stakeholders.
