

3. The Earnest Money Deposit of Rs. 25,000/- (Rupees Twenty Five Thousand only) by way of demand draft only drawn in favour of "Study of Atomic Processes for Multi-Charged Ions for Plasma Diagnostics". Payable at New Delhi shall be submitted along with Technical Bid. It should be spelt out exactly the way it has been asked for, failing which the bid is liable to be rejected.

The offers without EMD will be rejected. However, there is exemption of EMD applicable to the units registered with Central Purchase Organization (DGS&D), National Small Industries Corporation (NSIC) or the concerned Ministry or Department as defined under Rule 157 of General Financial Rules (GFR), 2005.
